Contact your local planning authority to ensure you follow all local business development laws, rules, regulations and guidelines. This guide is designed to assist you as you work to build and operate a successful food processing company in Kansas.

	U.S. Food and Drug Administration (FDA) www.fda.gov	Owners, operators, or agents in charge of domestic or foreign facilities that manufacture, process, pack or hold food for consumption in the United States are required to register the facility with the FDA. Log in and create an account to register a food facility . Additionally, firms that produce acidified foods or low-acid canned foods must file their processes with the FDA.	Prior to starting

	Department of Agriculture — Meat and Poultry http://agriculture.ks.gov	If wholesale meat processing is part of your processing company, look to the Meat and Poultry Inspection Registration website. The New Facility Packet provides guidance for the regulatory requirements of sanitation and the design and construction of meat and poultry slaughter and processing plants. The handbooks consists of information such as recommended building standards, registration requirements and HACCP consultants. 	Department of Agriculture — Weights and Measures http://agriculture.ks.gov	No license is needed from Weights and Measures, but a food processor with scales or other weighing or measuring devices must hire a licensed service company to place the devices into service and test once annually if the weighing or measuring devices are utilized for any commercial transaction. 	Department of Health and Environment — Bureau of Waste Management www.kdheks.gov	Facilities producing specialized organic waste may compost or apply this material to the land. Composting facilities less than one-half acre must register with KDHE, and facilities greater than one-half acre must obtain a permit . A permit must also be obtained to apply organic waste to land. For more information, review the KDHE Solid Waste webpage, or call 785-296-2751.	Prior to composting or land application
