



Pesticide Applicator, Sales & Business Licensing Guide

The Kansas Department of Agriculture is devoted to the total support of agriculture in Kansas. While we must fulfill our statutory obligations, the department is dedicated to providing support and assistance to make Kansas farms, ranches and agribusinesses successful and help them grow if that is their desire. We also encourage more farms, ranches and other agriculture business to expand in or relocate to Kansas. This checklist will help guide you through various resources and requirements for opening and operating a typical Kansas pesticide business. In addition to license requirements by the Kansas Department of Agriculture, other Kansas agencies as well as local or federal government agencies may have regulatory requirements to follow. Contact your local planning authority to ensure you follow all local business development laws, rules, regulations and guidelines. This guide is designed to assist you as you work to build and operate a successful pesticide business in Kansas.

	Department of Agriculture, Pesticide & Fertilizer	<p>Any person or business that applies pesticides is required to become licensed as a pesticide business by completing the Pesticide Business License application. Any person that applies pesticides commercially, whether as an owner or employee of a business, is required to receive a Commercial Certified Pesticide Applicator certification. Consult the Pesticide Applicator webpage for certification exam dates.</p> <p>Non-commercial pesticide application for agricultural use requires obtaining a Private Certified Pesticide Applicator certification by passing an open-book exam. Contact the local extension office for more information.</p> <p>Every pesticide business that applies pesticides for the control of wood-destroying (7A), structural (7E), ornamental (3A), turf (3B), or interior landscape (3C) pests and also employs uncertified applicators/technicians is required to have a registered technician training program. Complete instructions can be found at the Pesticide Applicator website.</p> <p>Pesticide dealers are required to register. Dealers are those who sell pesticide products. Licensed pesticide businesses that only apply pesticides do not register as a pesticide dealer. A licensed pesticide business that sells pesticide product without applying the product is required to have a pesticide dealer license. Details about pesticide dealer registration can be found at the Pesticide Dealer website.</p> <p>Secondary containment is required for all facilities where bulk pesticides are stored in excess of 1,000 gallons of liquid or 3,000 pounds of dry pesticides in any 365-day period. 	Department of Agriculture, Weights and Measures	No license is needed from Weights and Measures, but a pesticide business with scales must hire a licensed service company to test the scales once annually if the scales are utilized for any commercial transaction. 	Department of Health and Environment, Bureau of Water, Industrial Program Section	An NPDES Construction Stormwater Permit is required only if one or more acres are disturbed during construction. The permit is required prior to the start of soil disturbing activities. Visit the KDHE Industrial Programs website, or call 785-296-5549 for more information. National Pollutant Discharge Elimination System Pesticide General Permits are required for the application of pesticides to, over or near waters of the United States for the purpose of pest control. Review the KDHE Pesticide General Permit website for more information, or call 785-296-5551.	Prior to construction Prior to applying pesticide
	Department of Health and Environment, Bureau of Water, Public Water Supply & Geology Sections	If the facility will not utilize a municipal public water supply or rural water supply as the source of drinking water and the facility will serve 25 people or more per day, 60 or more days per year, it will be considered a public water supply subject to State/Federal drinking water requirements. Contact the KDHE Public Water Supply Section at 785-296-5514. Water wells shall be constructed by Kansas-licensed water well contractors. There are special construction requirements for water wells serving public water supplies. Contact the KDHE Geology Section at 785-296-5560 for more information.	Prior to construction
	Department of Health and Environment, Bureau of Water, Municipal Program Section	If the facility will employ an on-site wastewater treatment system rather than utilize a municipal sanitary sewer for handling and disposal of sewage from the facility, contact the KDHE Municipal Program Section at 785-296-5527 for construction and permitting requirements. 	Department of Health and Environment, Bureau of Environmental Remediation, Storage Tank Section	Entities operating their own fuel tanks may be required to registered with KDHE. Review information about aboveground storage tanks (AST) and underground storage tanks (UST) . Review the KDHE Storage Tank Section website for further information, or call 785-296-1678 for permitting information. *The Kansas Small Business Environmental Assistance Program (SBEAP) has AST program highlights and registration requirements in addition to assistance with UST inventory control .	Prior to installing tanks, Annual Renewal August 1
	Department of Health and Environment, Bureau of Air	Gasoline dispensing facilities are subject to federal air regulation. A guidance document is available to assist in determining regulator requirements. Contact the KDHE, Bureau of Air , at 785-296-1570 for additional information.	Prior to dispensing fuel
