### COMMERCIAL CERTIFICATION EXAMINATION SCHEDULE

December 2017 - March 2018

These examinations are to provide an opportunity for pesticide applicators to qualify for original or renewal commercial certification under the Kansas Pesticide Law. Study manuals are available: KSU Bookstore:<http://www.communications.k-state.edu/doc/forms/Pesticide-Order-Form2016.pdf> or some downloaded for free: <http://www.k-state.edu/pesticides-ipm/commercial-applicator.html> or by calling the KSU Bookstore at (785) 532-5830 or County Extension Offices.

**All examinations begin at 9 am and must be completed by 12 noon.** Applicants must furnish current photo identification prior to taking examinations. A valid Kansas driver's license is preferred. Preregistration is not currently required. Do not bring cell phones, calculators or study material into the exam room. You may ask the examiner for a calculator. If you need further information, call (785) 564-6688.

**Exam Fees:** All exams are \$45 each. The General Exam and any retakes are also \$45 each. Applicants must pay fees at the time of the examination.

**Cash will not be accepted.**

Check, credit card or money order to KDA is required. Name on credit card must match signature on credit card form.

For initial certification, both the General and one category/subcategory exam must be passed within 12 months of each other. If you pass one of the exams, you have 12 months from the date you passed that exam to pass the second exam. You are not certified until you pass both exams. Applicants must be 18 years of age or older to be eligible for commercial applicator certification.

**All subcategories in a category expire the same year** regardless of when additional exams are taken. Categories are 1, 2, 3, 4, 5, 6, 7, 8, 9 & 10.

**To Renew** – Applicators may test beginning in October of the year their certification expires.

The General exam is required when renewing by testing, including late reentry after Dec 1<sup>st</sup>.

Exam results will be e-mailed or mailed to you using the address on your application and not by phone.
