

## **Food Safety Fact Sheet**

Licensed Egg Producer

Egg Handout: Licensed Egg Producer, May 2016

The Kansas Department of Agriculture (KDA) is responsible for enforcing the Kansas Egg Law. The Kansas Egg Law requires an egg producer license to sell graded eggs or to sell eggs to other than the end consumer, regardless of the size of the production flock.

The license fee is \$5.00. The license expires on December 31 and must be renewed annually. The license fee and Egg License Application must be submitted to KDA. If you are a producer who sells graded eggs to the end consumer or sells eggs to grocery stores, restaurants, or institutions, you must pay the egg inspection fee in addition to the egg producer license fee. The egg inspection fee is 3.5 mills (\$0.0035) per dozen eggs. The egg inspection fee can be paid quarterly or per dozen. To pay quarterly you must submit the Quarterly Fee Application portion of the Egg License Application. The Egg Quarterly Inspection Report and the correct egg inspection fee must be submitted to KDA by the end of each quarter. There is a \$15.00 minimum egg inspection fee per quarter.

Alternatively, the egg inspection fee can be paid by purchasing from KDA egg inspection fee stamps to be affixed on each carton. One egg inspection fee stamp covers the egg inspection fee for one dozen eggs. Egg inspection fee stamps come in rolls of 1,000 stamps. Each roll of 1,000 stamps is specific to a combination of size and grade, or the generic stamp can be used and the size and grade written on the stamp. The stamp must be dated, which serves to cancel the stamp.

Each container of graded eggs must meet the labeling requirements of the Kansas Egg Law. The outside of each carton must be labeled with:

- The size and quality of eggs, which must be printed in boldface type letters at least 3/8 inch high
- The identity of the eggs (for eggs other than chicken eggs, for example duck, goose, etc.)
- The name and address of the packer
- The pack date (month/day or Julian date)
- The expiration date preceded by "exp." or "sell by" (should not exceed pack date by more than 45 days)
- Safe handling instructions that must include the statements:
  - o "Keep refrigerated at or below 45 degrees Fahrenheit" printed on the outside of the carton
  - o "To prevent illness from bacteria: Keep eggs refrigerated, cook eggs until yolks are firm, and cook foods containing eggs thoroughly" printed either on the outside or the inside of the carton.

All labeling information must be in English and must be accurate.

There are no specific requirements for egg graders. All eggs must meet the size and grade requirements in USDA AMS 56 (July 2000)
