PREHEAIRNG ORDER AND NOTICE OF PREHEARING CONFERENCE

The above captioned matter comes before the Presiding Officer/Administrative Law Judge (ALJ) to issue this prehearing order.

- 1. By letter dated October 20, 2022, The Water Transfer Hearing Panel requested a Presiding Officer from the Office of Administrative Hearings (OAH), be appointed to conduct a hearing regarding a water transfer application pursuant to K.S.A. 82a-1501a(b).
- 2. Upon receipt of the application and associated documentation, on October 27, 2022, the undersigned ALJ was appointed to serve as the Presiding Officer over this proceeding.
- 3. The Water Transfer Act (WTA)¹ provides that within fourteen (14) days after the Presiding Officer is assigned, the Presiding Officer is to commence the proceeding by providing notice of a prehearing conference.² The WTA further specifies the prehearing conference is to be held at least 90, and no later than 120 days after commencement of the proceeding.³
- 4. Notice is provided below of the prehearing conference scheduled to be held on **February 15**, **2023 at 10:15: a.m**. This prehearing conference will be held by Zoom video conference. Only representatives of the parties and those allowed to intervene will be permitted to make comments. All others who may join the proceeding will be muted with no video.
- 5. The WTA requires notice of the prehearing conference to be published in the Kansas Register and at least two newspapers of general circulation in the area where the proposed point of diversion is located.⁴ The proposed point of diversion is located in Edwards County, Kansas,

and is located within the boundaries of Big Bend Groundwater Management District No. 5 (GMD5). GMD5 covers parts of the following counties: Barton, Edwards, Kiowa, Pawnee, Pratt, Reno, Rice, and Stafford. Accordingly, notice of the prehearing conference will be published in the following newspapers:

- 6. This matter is currently before the Presiding Officer with the Office of Administrative Hearings (OAH). OAH is an independent entity and not a part of the Water Transfer Panel; the Kansas Department of Agriculture, Division of Water Resources; or the Kansas Department of Health and Environment. Any pleading filed with OAH should properly reflect that it is being filed before the Office of Administrative Hearings.
- 7. Parties may either submit filings to OAH by mail, fax, e-mail, hand-delivery, or electronic filing through the OAH E-File system. Only one copy of any filing should be submitted to OAH, regardless of the method of filing used. No bench copy is necessary. Parties may register to use the OAH E-File system on the OAH website, www.oah.ks.gov. The E-File system allows parties to file and receive service of filings electronically.
- 8. The WTA permits intervention in this proceeding in accordance with the Kansas Administrative Procedures Act. Any petitions for intervention should be filed with OAH and served on all parties no less than 60 days prior to the formal hearing date.^{5, 6}
- 9. If the prehearing conference cannot be concluded on February 15, 2023, it may be continued for additional settings within the next 45 days as deemed necessary by the Presiding Officer.

Notice of Prehearing Conference

You are hereby notified that a prehearing conference in the above captioned matter will be held on **February 15, 2023 beginning at 10:15 a.m.** The prehearing conference will be held by zoom video conference. To participate in the prehearing conference, you may use Zoom software or go to www.zoomgov.com. Enter **Meeting ID:** 160 441 2271 and **Passcode:** 185875.

If you attempt to join before the Presiding Officer has opened the video conference link, you may be placed into a waiting room until the proceeding begins. If you have been waiting more than five (5) minutes before the Presiding Officer begins the proceeding, you may be disconnected by the
