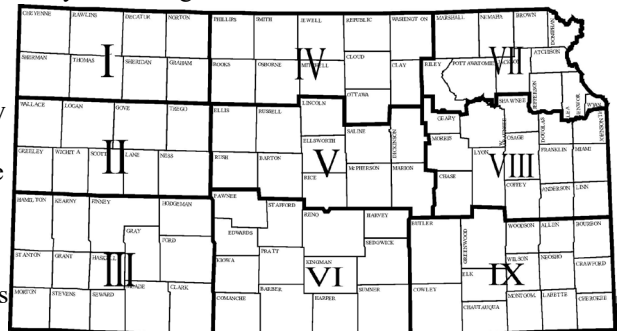

## Election Procedure

Upon registering to vote by **December 31, 2023**, either by filling out the Commodity Voter Registration form that can be obtained from your county extension office, your county conservation district office, the Kansas Department of Agriculture, or any of the five grain commodity commission offices (corn, grain sorghum, soybeans, wheat or sunflowers), or by signing a valid candidate petition form; you will receive a ballot by mail by **January 15, 2024**. You have until **March 1, 2024**, to submit your ballot to the Kansas Department of Agriculture. The candidate winners will take office **April 1, 2024**. Any challenge of voter eligibility, the petition process, or any other election procedure must be submitted in writing to the Secretary of Agriculture between **February 20, 2024**, and one week after ballots are officially counted and winners announced. The Secretary of Agriculture or his designee shall serve as the final arbiter in any disputes that may arise out of the election procedure.



Those in the western three districts (I, II, III) are eligible in this commodity election year. Successful candidates begin their terms April 1, 2024.
