Grain Warehouse

Pursuant to K.S.A. 74-120 and Executive Order 18-13, the Kansas Department of Agriculture, Plant Protection and Weed Control Program provides the following information pertaining to specific civil and criminal records that could disqualify an applicant from receiving a license, certification, registration or permit issued by the Department.

K.S.A. 34-228, pertaining to warehouseman's licenses, provides that "no license shall be issued to a person or entity not previously licensed in this state and making application for an original license who, in this state or any other jurisdiction, within the 10 years immediately prior to the date of the application of the person or entity for a license, has been convicted of ..." any offense listed below.

If you have questions regarding licensure, you should review the Kansas Grain Warehouse Law, or contact the Plant Protection and Weed Control Program.

Additionally, you may contact the Kansas Department of Agriculture and petition for an informal written advisory opinion concerning whether your civil or criminal records will disqualify you from receiving a license, certification, registration or permit.
