Licensing Guide for Industrial Hemp Producers

The Kansas Department of Agriculture (KDA) is devoted to the support of agriculture in Kansas. While we must fulfill our statutory obligations, the department provides support and assistance to make Kansas farms and agribusinesses successful and help them grow if that is their desire. We also encourage more farms and other agriculture businesses to expand in or relocate to Kansas. This guide is designed to assist you as you work to build and operate as an industrial hemp producer in Kansas. In addition to license requirements by KDA, other Kansas agencies, as well as local or federal government agencies, may have regulatory requirements to follow. Contact your local planning authority to ensure you follow all local business development laws, rules, regulations, and guidelines.
