V.	<p>4 members were in favor of the bill as it is written. 4 members were opposed for the following reasons:</p> <p>Dawn Bryant and Greg Smith objected to the addition of K.S.A. 47-1725(a)(11): <i>“one member shall be licensed rescue network manager”</i></p> <p>Lorilee Thomas objected to the addition of K.S.A. 47-1725 (a)(11): <i>“one member shall be licensed rescue network manager”</i> and the wording in K.S.A. 47-1709 (d)(2) <i>“Upon notification to the commissioner by a licensee of the date such licensee ceases or plans to cease to engage in activity requiring licensure pursuant to this act, the commissioner or the commissioner’s authorized representatives may conduct a closing inspection to confirm such activity has ceased prior to expiration of the license period.”</i> She would like the word “may” to remain instead of being changed to “shall”.</p> <p>Kendra Titus opposed the bill in its entirety. She was opposing on behalf of those she represents.</p>
