



# Kansas Seed Law Registration Application



- All persons selling agricultural seed such as grass, legume, forage, cereal and fiber crops are required to register with the Secretary of Agriculture. Persons selling horticultural seed such as vegetable or flower seed are exempt from licensing and fees.
- Persons selling agricultural seed to any person other than the end user are required to obtain a wholesale registration.
- Persons selling agricultural seed to the end user are required to obtain a retail registration.
- Persons selling as both a retailer and a wholesaler are required to register as both a retailer and a wholesaler.
- Seed conditioners are required to register with the Kansas Department of Agriculture. No fee is required for registration.
