Kansas Department of Agriculture — Certificate of Free Sale  <a href="http://www.agriculture.ks.gov">www.agriculture.ks.gov</a>	Many countries require a Certificate of Free Sale, sometimes called a "Certificate for Export" or "Certificate to Foreign Governments." The certificate is an assurance that the products listed on the certificate are eligible for export and approved by the regulatory authorities in the country of origin. If your business is looking to obtain a Certificate of Free Sale, please reference this <a href="#">document</a> from the Kansas Department of Agriculture.
Export-Import Bank of the U.S. (EXIM)  <a href="http://www.exim.gov">www.exim.gov</a>	<a href="#">Export-Import Bank of the U.S.</a> is the official export credit agency of the United States. When private sector lenders are unable or unwilling to provide financing, EXIM fills in the gap for American businesses by equipping them with the financing tools necessary to compete for global sales. EXIM assumes credit and country risks that the private sector is unable or unwilling to accept.
Food Export-Midwest  <a href="http://www.foodexport.org">www.foodexport.org</a>	<a href="#">Food Export-Midwest</a> is a non-profit organization that promotes the export of food and agricultural products for businesses in its 13 Midwestern-state members. The services that they offer include export promotion, customized export assistance and a cost-share funding program. Foreign-Trade Zones (FTZ)  <a href="http://enforcement.trade.gov/ftzpage">enforcement.trade.gov/ftzpage</a>	Foreign-Trade Zones are secure areas under U.S. Customs and Border Protection (CBP) supervision that are generally considered outside CBP territory upon activation. Located in or near CBP ports of entry, they are the United States' version of what are known internationally as free-trade zones. Foreign and domestic merchandise may be moved into zones for operations not otherwise prohibited by law, including storage, exhibition, assembly, manufacturing and processing. The Foreign Agricultural Service also publishes the Food and Agricultural Import Regulations and Standards, which includes regulatory and documentary requirements for a market.

International Freight Forwarder  <a href="http://www.ncbfaa.org">www.ncbfaa.org</a>	<a href="#">International Freight Forwarder</a> is an agent for moving cargo to an overseas destination. These agents are familiar with the import rules and regulations of foreign countries, the export regulations of the U.S. government, the methods of shipping, and the documents related to foreign trade.

Some exemptions may exist. Before exporting livestock from Kansas, visit APHIS’ <a href="#">International Regulations (IRegs)</a> for specific state of destination requirements.</p>

This is a gateway to information on all Free Trade Agreements and Trade Promotion Agreements the U.S. has with other nations.</p>

Exports of used agricultural equipment to California also require certification.
