7. FINANCIAL REPORT: (See Attachment A)

- a. FY 2018 year-end financial report - Frost
 - * CREP has experienced resurgence this year; there are more acres enrolled than money.
 - * Looking at reorganizing current CREP or creating new CREP.
 - * Conservation Technician program is growing.
 - * Land Reclamation/Ag Lime is in much better shape compared to last year due to software programming being paid out and increased fee funds.
 - * Would rather have carryover than encumbrance. We lose encumbrance dollars if contracts are cancelled.

8. UNFINISHED BUSINESS:

- a. Determine FY2019 cost-share cancellation/reallocation policy (tabled from April 16, 2018, meeting) – Jones (See Attachment B)
 - * Cancel all uncommitted FY 2019 cost-share funds in the Non-Point Source Pollution Control Program (NPS) on December 7, 2018. First priority for reallocation would be to Livestock Waste System applications (if needed), Streambank Protection projects (if needed), and any special initiatives (if needed). Second priority would be to relocate statewide.
 - * Cancel all uncommitted FY 2019 cost-share funds in the Water Resources Cost-Share Program (WR) on December 7, 2018. First priority for reallocation would be to any special initiatives (if needed). Second priority would be to reallocate statewide.

Dave proposed to have the cancellation date of December 7, 2018. Special initiatives are first priority and reallocating statewide is second priority. The only one active is the drought initiative.

Karen Woodrich, NRCS, said that NRCS will have another drought initiative sign-up date and that areas and dates will be expanded as drought area is expanded.

A motion was made by Brad Shogren to approve the FY 2019 cost-share cancellation policy recommendation of December 7, 2018, and to table the reallocation policy discussion until the November SCC meeting. The motion was seconded by Andy Larson. Motion carried.

- b. Third Party Easement Update – Reschke

- * DOC is looking to be third party easement mitigation holder on new structure for Marmaton Watershed District.
 - * DOC will receive \$10,000 for the mitigation fund which is established by statute.
- c. Discuss DOC Reviews – Reschke (Attachment C)
- * Donna compiled report. Every county is reviewed every three years.
 - * Review is very thorough and is looked at as educational to both Conservation Districts and DOC. Donna works with the District Managers in making corrections.
 - * Some problems are being taken care of before Donna does the review, which goes back to the Financial Management Report and the efficiency and effectiveness of administering funds. Conservation is the most important factor, but we all still need to be fiscally responsible.
 - * Donna has good working relationship with District Managers - does roughly 35 reviews per year.
 - * Rod said that the Financial Management Checklist has helped quite a bit and has been a good thing. Asked if there is something similar for ranking and cost-share applications at the local level to make sure this is all being done correctly.
 - * The effort put forward by District Managers utilizing the ranking worksheet is very noticeable.
 - * John asked if there is there a ranking worksheet checklist for the District Managers to follow and attach to ranking worksheet; suggested so supervisors know ranking is being done properly.
 - * Rod added that this could be used as a tool to help supervisors understand the ranking process. Could also be beneficial to use as part of a training since so many don't attend meetings.
 - * Dave is working on trying to make things more automated and real time in CSIMS so we don't have to wait until DOC gets out to do reviews.

9. NEW BUSINESS:

- a. Discuss SCC luncheon at KACD convention – Reschke (See Attachment D)
- * Jim Gulliford, Regional Administrator of EPA Region 7, has accepted the invitation to speak at the SCC luncheon. Cindy is taking care of details for his arrival.
- b. Review and discuss DOC Disaster Cost-Share Funds Policy – Jones (See Attachment E)
- * Thought it would be good time for Commissioners to review policy given what's been happening (drought); suggested keeping the conversation alive.
 - * Do we need to make changes? Has been several years since policy was updated.
 - * Ask that Commissioners review the policy and think of ideas how to revamp the policy to make it more flexible, what we can do in disaster situations, as well as improving the response time.
 - * John agreed this is a great idea. We need to be more proactive and ready.
 - * Rob expressed that the ability to have specific funds to carry over year to year would be nice.

- c. Discuss Livestock Water Supply Financial Assistance Initiative – Reschke/Jones (See Attachment F)
 - * Since announcement, Dave got inundated with requests for high need of pumping plant. He highly recommends adding pumping plant to the practice list.
 - * There were several requests for small winter-feeding areas; the recommendation is to stay at the 40-acre minimum for consistency sake.
 - * The situation is very fluid on this, and additional counties may be added.

A motion was made by John Wunder that the requirement of a 40-acre minimum pasture size be kept in the Livestock Water Supply Financial Assistance Initiative and that pumping plant be added to the Livestock Water Supply Financial Assistance Initiative as an eligible practice. The motion was seconded by Brad Shogren. Motion carried.

- d. Discuss Kansas Sediment and Nutrient Reduction Initiative – McCoy (See Attachment G)
 - * Has list of CRP practices that will be allowed by regulations for the initiative which are very common.
 - * Decided to open up to Upper Republican Watershed first to meet some match requirements for Regional Conservation Partnership Program (RCPP). There will be two different kinds of tiers for payment amounts, as well as a continuous sign-up and a single one-time payment.
 - * It depends on what area landowners are in as far as how much payment is; it is a first-come-first serve.
 - * Stream team will now be paying for buffers out of pool funding. Originally it was handled by Riparian/Wetland Program – going through stream team has opened up more money for our program.
- e. Discuss Riparian and Wetland Cost-Share Program - McCoy
 - * Eventually will work on putting together a program focusing on cattle and creeks to try encouraging producers to take the next step and do more than just the bare minimum.
 - * Initiative is in really good planning stages; Tim has been working with Andy Klein, Kansas Forest Service, on this. Working with KDHE to develop priority targeting areas.
 - * Main resources concern is water quality (Commission commented that the addition of NRCS grazing management plans should be included to allow flashgrazing of the riparian area and to help address additional resource concerns in the riparian area and associated grazing area.
- f. Discuss On-Site Waste (OSW) cost-share – Jones (See Attachment H)
 - * We can keep doing things the same or look at doing things differently - need to keep this on the forefront.
 - * Soil testing and well plugging were mentioned as similar practices; well plugging has a lower project limit.
 - * Most counties are contracting with extension offices on soil testing.
 - * On-site waste cost-share has historically benefitted KDHE.
 - * Dan suggested reviewing OSW and NPS again in the cost-share manual.

- g. Review FY 2019 WR and NPS cost-share allocation maps – Jones (See Attachment I)
 - * Dave reviewed cost-share allocation maps he put together maps per SCC request; interesting to see formula similarities in different parts of the state.
 - * With SCC blessing, he will continue with these maps and prepare them for the April meeting.
 - * It is good to have visuals instead of just spreadsheets – can learn a lot in a hurry with visuals and it is easy to see trends. Would like to have maps added to website.
 - * John mentioned that we need a comprehensive communication strategy. People feed off of Twitter – maybe tweet dollar amount put into drought initiative? If we're talking about sustainability, we need proper communication.
- h. Review and take possible action on FY 2019 WDCP Cost-Share Applications for new dam construction – Reschke (See Attachment J)
 - * This one is a little different – is for new construction. This is to approve funding so they can get started. All permits and funding have been obtained so they can get started a month earlier.

A motion was made by John Wunder to approve the FY 2016 and FY 2017 cost-share encumbrance policy recommendations. The motion was seconded by Ted Nighswonger. Motion carried.

11. REPORTS:

a. Agency Reports:

- * Dan Devlin, KCARE – New Provost, the Chief Operating Officer, has no agriculture or land reclamation experience; is from New York and is starting August 1. In hiring freeze; 7.3% budget cut was announced. Has had lot of interest in water technology farms. 10 field days this month. Hemp legislation got passed; State level committee working on it through KDA.
- * Terry Medley, DWR – All grant applications stayed pretty much same, technical grant up just a bit, community assistance grant went down slightly, and is requesting more. Kansas inter-agency meeting held at Emporia NRCS building Thursday. Planning on putting on watershed administration workshop in October. Working on forming new watershed district in Clay County. Still many vacancies in DWR open.
- * Karen Woodrich, NRCS – drought initiative as of last week had over \$1.6 million in requests. Requested \$1 million initially but intend to go back and ask for full funding. Have been talking with DOC and others on making sure all get same opportunity. Looks hopeful this will be done in next month or so.

- * Stephanie Royer, KACD-EO – was not present but provided report (See Attachment K)

b. Staff Reports:

- * Tim McCoy – Six sites on the Cottonwood are almost ready for design. Is pushing ground truthing on all watersheds once crops are out. Blue river has five sites completed with nine bids for construction. Has four designs from Wildhorse River Works funded by state revolving loan. Cottonwood has two sites ready for completion. Delaware has two more sites to complete construction with four more in being contracted. Ground truthing is aerial photography from years past and most recent year. Can draw in how much has been lost due to erosion, then go out to site to make sure it hasn't stabilized itself naturally.

- * Dave Jones – none

- * Cindy Pulse – Will be interviewing to fill a student worker position. Steve and Cindy have been working with Heather Lansdowne, Jason Walker, and Dana Ladner on obtaining an ag communications intern that will be able to assist with the education outreach project and possibly a Facebook page. Ag lime tonnage reports and license renewals are complete. Scott has been spot-checking mine sites on Google Earth Pro – has been in contact with companies to increase bonds and acreages due to under-reported mine site acres. Leading on-going monthly strengths activities till the end of the year.

- * Steve Frost – Mentioned that Mid-States Materials, LLC received the 2018 Outstanding Reclamation Award for their Big Springs Quarry.

c. Commissioner reports:

- * Ted Nighswonger – has been getting rain. Water Authority will be meeting day before the Ag Summit.

- * Brad Shogren – has been getting a little rain, corn has burned up, beans are recovering.

- * Andy Larson – soil health 2-day event next week - will be interesting.

- * John Wunder – next two weeks will be busy - KACD next week. KWA meeting and Ag Summit should be very diverse and a great way to market DOC, SCC, and NRCS as partners and get ag out there from natural resource perspective.

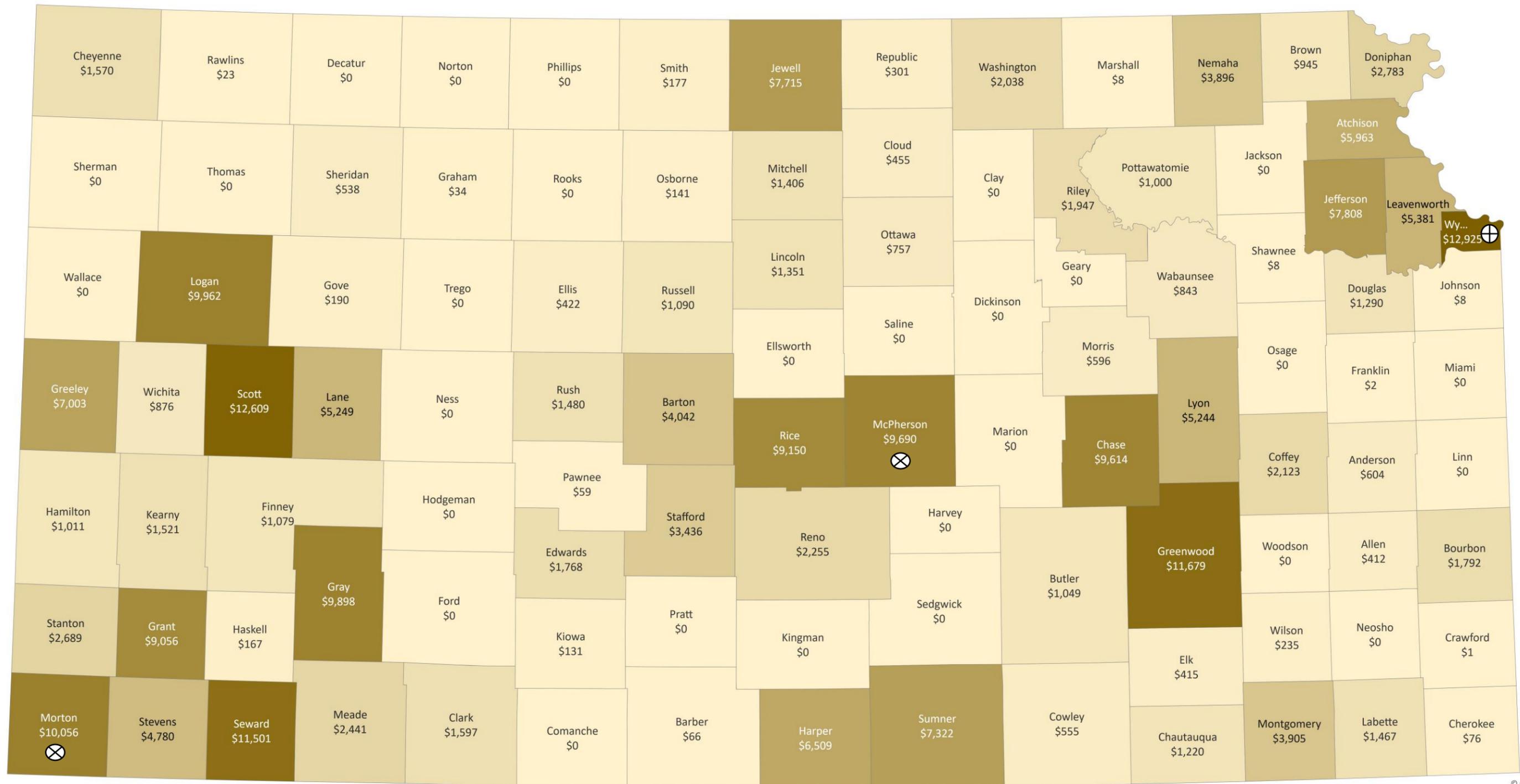

 - c. Discuss DOC Reviews

Cost-Share Reviews

- In FY 2018, cost-share and operation reviews were conducted in 37 counties. In addition, 2 spot checks were conducted. A total of 8 cost-share contracts were overpaid totaling roughly \$8,035 in overpayments to landowners.
- Currently in FY 2019, cost-share and operation reviews have been conducted in 12 counties thus far. In total, 33 counties will be reviewed this FY 2019. In addition, spot checks will be conducted as needed.

These were some of my findings from the FY 2018 cost-share reviews:

- There were several counties that had the CS-3 Contract for Financial Assistance in the contract file, but the CS-3 was not signed by the landowner or the signature of the landowner was a photocopy.
- There were several counties that had the CS-4 Final Payment in the contract file, but not signed by NRCS.
- NRCS final check out sheets were not always in the contract files.
- There were numerous counties that didn't have the required Grazing Management Plan in the file and/or it wasn't signed by the landowner.
- There were several counties that didn't have the AWP Well Plugging Worksheet in the contract file.
- The Ranking Worksheet for individual landowners were not always found in the contract files which are printed out of CSIMS. (This oversight should be eliminated in the new version of CSIMS as districts will have to create the ranking worksheet to turn it into a contract.)
- There were several counties that didn't have all the correspondence to the landowner in the contract file (i.e. contract signature request, approval of CS-3, payment notification, etc.).
- In a handful of counties, District Managers were not amending contracts to reflect the actual units installed when processing for payment. In some instances, it was because the payment amount didn't change due to project type limit/landowner limit/available funds. However, in other circumstances, it created an overpayment to the landowner. (This error can be eliminated in the new version of CSIMS as we are requiring districts to upload the NRCS check out sheet when processing for payment. This will aid in ensuring that contracts are amended to reflect actual units installed.)
- There were several counties that didn't have the required OSW eligibility criteria worksheet in the contract file. (This oversight will be eliminated in the new version of CSIMS as DOC will be requiring districts to complete an OSW eligibility criteria worksheet online when creating the CS-3 Contract for Financial Assistance application.)
- There were several counties that didn't have the WWC-5P form in the contract file. (This oversight will be eliminated in the new version of CSIMS as DOC will be requiring districts to upload the WWC-5P when processing for final payment.)

- There were several counties that didn't have the OSW county permit in the contract file. (This oversight will be eliminated in the new version of CSIMS as DOC will be requiring districts to upload the OSW county permit when processing for final payment.)
- It was discovered on a couple of contracts that the "shaping" component was paid under both Practice Code 342 and 412. (This oversight should be eliminated in the future as DOC updated language in the DOC Programs Manuals to reflect that if Practice Code 342 is in conjunction with Practice Code 412, then shaping is not allowed under Practice Code 342.)

Operation Reviews

- Several districts didn't have a Personnel Policy Handbook on file. (I have emailed those counties an example.)
- Several districts didn't have a signed Employee Agreement. (I have emailed those counties an example.)
- Several districts didn't have a District Credit Card Policy on file. (I have emailed those counties an example.)
- Several districts didn't have the board review, sign and date employee time sheets. (A "Did You Know" email was sent statewide to assist with this oversight.)

Disaster Cost-Share Funds**General Policies**

The DOC may authorize a Disaster Cost-Share Program when significant disaster events occur within the state. The purpose of the program is to provide state cost-share assistance to landowners that need to replace disaster event damaged or destroyed conservation practices.

Qualifying Disaster Events

1. 25 year-24 hour rainfall event.
2. FSA Crop Disaster Declaration
3. Presidential Disaster Declaration.
4. Governor's Disaster Declaration.
5. Other conservation district requests will be considered by the DOC.

Eligible Practices

1. Following a qualifying disaster event a district selects which practices are eligible for disaster cost-share assistance.
2. Eligible practices: All cost-share practices offered by the DOC are eligible at the discretion of the conservation district.

Landowner Limits

1. Not to exceed \$5,000.
2. District may set landowner limit by practice.

Cost-Share Rate

1. Not to exceed 70%.

Prioritizing Applications

1. Districts shall prioritize practices before a sign-up begins.
2. Districts shall prioritize on a first come-first served basis.

Funding Source

December and April 1 Cancelled Funds: If available, a portion of the uncommitted statewide cost-share funds that are cancelled on December (1st Friday) and April 1 may be utilized.

Disaster Cost-Share Assistance Allocations

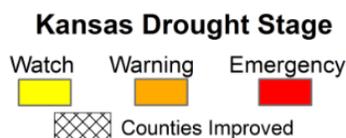
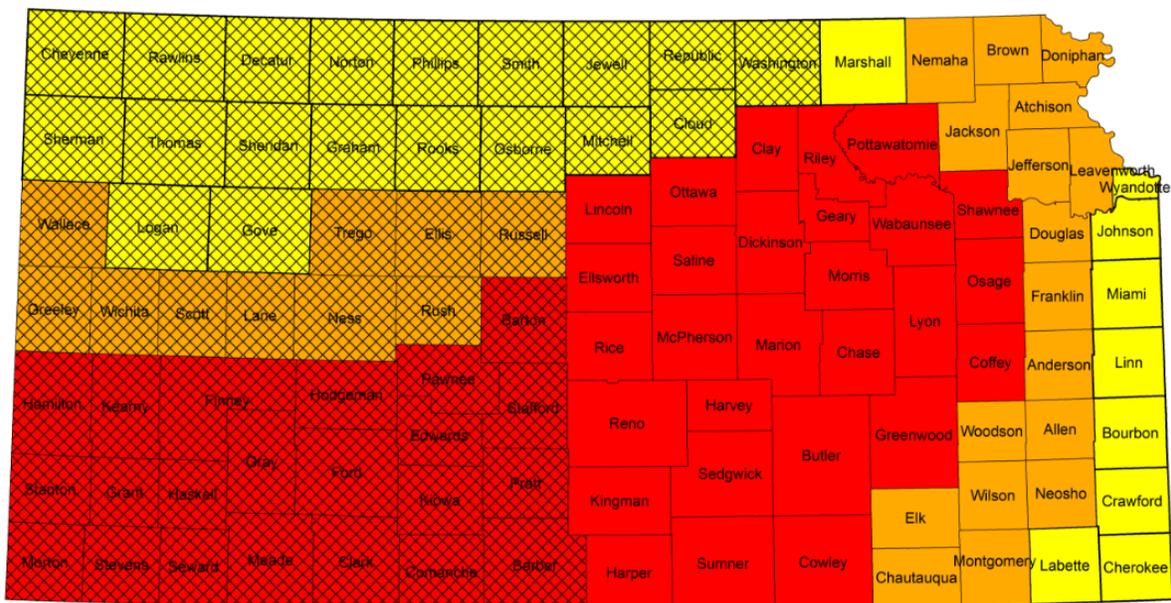
The DOC will designate districts eligible for disaster cost-share assistance funds when requested by a district. The DOC will then determine the amount of disaster cost-share funds to be allocated to the requesting district. When a district allocation is official, a district may then begin the sign-up period.

Livestock Water Supply Financial Assistance Initiative

- DOC has received requests for the addition of pumping plant as an eligible practice. All types of pumping plants wanted. Average costs vary depending on the type of pump. Average cost would need to be determined by DOC.

Re: Livestock Water Supply Financial Assistance Initiative

The Kansas Department of Agriculture, Division of Conservation is pleased to announce the availability of funds to assist landowners that have previously drilled livestock water supply wells in response to the ongoing drought. Previously installed livestock water supply pipeline and tanks are also eligible for funding. The State Conservation Commission took action on July 31, 2018 to approve funding that will provide financial assistance for livestock water supply wells, pipeline and tanks installed after June 1, 2018 and before the announcement of the Environmental Quality Incentives Program (EQIP) Drought Initiative by NRCS on July 24, 2018.

Following is additional program guidance on the Retroactive Livestock Well Incentive Payment Initiative:

- Applications will be accepted from August 1st thru August 31st 2018.
- Eligible livestock wells, pipeline and tanks must have been installed or have started the installation process between the dates of June 1, 2018 and July 24, 2018.
- Eligible livestock wells, pipeline and tanks must serve pastures 40 acres or larger with a permanent perimeter fence.
- Landowners must provide a copy of the completed WWC-5 Water Well Record form for all wells drilled.
- Landowners must provide copies of all bills pertaining to drilling the livestock wells, installing livestock water supply pipeline and installing tanks.
- Landowners must certify that these practices are being used for livestock water supply and no other purpose.
- Eligible areas will be the same as the NRCS EQIP 2018 Environmental Quality Incentives Program (EQIP) Drought Initiative. These eligible areas are located in the following Kansas counties:
 - Barber, Barton, Butler, Chase, Clark, Clay, Coffey, Comanche, Cowley, Dickinson, Edwards, Ellsworth, Finney, Ford, Geary, Grant, Gray, Greenwood, Hamilton, Harper, Harvey, Haskell, Hodgeman, Kearney, Kingman, Kiowa, Lincoln, Lyon, Marion, McPherson, Meade, Morris, Morton, Osage, Ottawa, Pawnee, Pottawatomie, Pratt, Reno, Rice, Riley, Saline, Sedgwick, Seward, Shawnee, Stafford, Stanton, Stevens, Sumner, and Wabaunsee.

- The DOC will approve applications until all specified funds are allocated at the end of the sign-up period.
- Applications will be ranked based on criteria developed and approved by the SCC.
- Districts will need to accept applications for the full 30-day sign-up period and forward all applications to the DOC at the end of the sign-up period. This will allow the DOC to have an accurate inventory of applications.
- The DOC will approve applications as soon as possible after the sign-up ending date.
- The DOC does not guarantee adequate funds will be available to fund all eligible applications.
- **Practice Code 642 (Water Well) will have a statewide county average cost of \$25.00 per linear foot of depth with a cost-share percentage of 50% under this initiative.**
- **Practice Code 516 (Pipeline) will have a statewide county average cost of \$3.00 per linear foot with a cost-share percentage of 50% under this initiative.**
- **Practice Code 614 (Watering Facility) will have a statewide county average cost of \$1.50 per gallon with a cost-share percentage of 50% under this initiative.**
- **Landowners with approved applications will sign a 10-year maintenance agreement for the practices as installed.**
- **The total landowner limit for financial assistance will be \$6,000 under this initiative.**

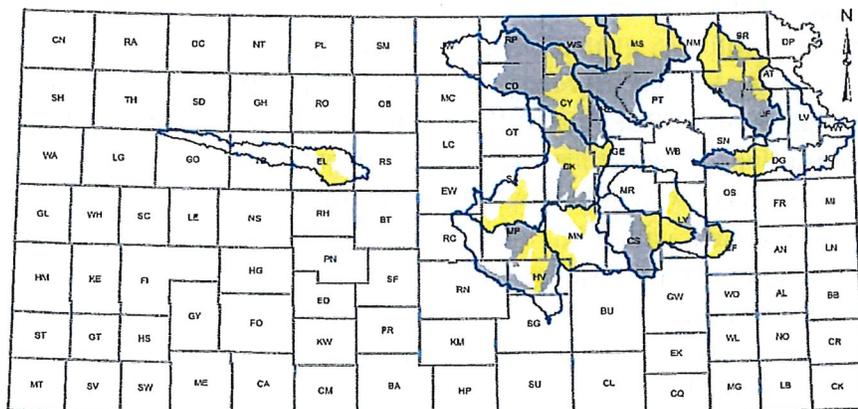

Kansas Sediment and Nutrient Reduction Initiative

- \$281,000 from the Legislature to incentivize enrollment in CRP in targeted Hydrologic Unit Codes (HUC 12s).
- Producers who are accepted into the CRP program will be eligible for a single payment of \$225 per acre for tier 1 HUC 12s and \$162.50 per acre for tier 2 HUC 12s.
- The following CRP conservation practices (CP) will be promoted through the program
 - CP8A- Grassed Waterways
 - CP9- Shallow Water Areas for Wildlife
 - CP21- Filter Strips
 - CP22- Riparian Buffers
 - CP23- Wetland Restorations
 - CP27,28- Improvements to Farmable Wetlands and Farmable Wetland Buffers

Riparian Quality Enhancement Initiative

- \$94,000 from Riparian and Wetland fund is available for the initiative.
 - Made available from Streambank Team decision to fund buffers as part of the pooled funding.
- Emphasis on the initiative is to cost share on projects that provide the greatest benefit to riparian areas. Projects will be separated into Tier 1, 2, and 3 categories:
 - Tier 3 Projects: Establish new watering facilities to decrease livestock presence in the riparian area. These projects will receive 80% cost share up to a landowner limit of \$3,500. They will also have the lowest ranking preference.
 - Tier 2 Projects: Establish new watering facilities and fence the riparian area away from livestock access. These projects will receive 80% cost share up to a landowner limit of \$7,500. They will also have a higher-ranking preference over Tier 3 projects.
 - Tier 1 Projects: Establish new watering facilities, fence the riparian area away from livestock access, and enhance the riparian area to improve function and wildlife habitat. Riparian improvements may include installation of Riparian Buffers as planned by KFS or wetland developments as designed by NRCS or other approved technical service provider. These projects will receive 80% cost share up to a landowner limit of \$10,000. They will also have the highest-ranking preference. Landowners accepted will be asked to allow limited tours of the area to promote the initiative for the length of the contract.
- Additional Information:
 - Areas denoted by KDHE as having an impairment due to livestock will be the initial targeted regions of the initiative.
 - Pastures must have blue line streams as denoted by a KGS quad map.
 - The entire length of the stream must be fenced to be eligible as a tier two project under the initiative.
 - A project that has an adequate watering system but is interested in fencing the riparian area will be Tier 2 eligible. A project that has water and has fenced the riparian area would be eligible for Tier 1.

Proposal for Kansas Department of Conservation- Division of Conservation (KDA-DOC) Riparian Quality Enhancement Initiative (RQEI).

Proposal:

Utilize riparian oriented projects to improve water quality, riparian area health, and wildlife habitat. These projects will emphasize the removal of livestock from riparian areas and will include: Livestock Pipeline (516), Watering Facility (614), Pumping Plant (533), Water Well (642), Spring Development (574), Pond (378), Windbreak and Shelterbelt Establishment (380), Windbreak and Shelterbelt Renovation (650), Heavy Use Protection (561), Fence (382), Critical Area Seeding (342), Stream Crossing (578), Riparian Forest Buffer (391), Tree and Shrub Establishment (612), Wetland Creation (658), Wetland Enhancement (659), Wetland Restoration (657). Landowners will be awarded cost share for these projects based upon a project proposal form and a tiered cost share amount dependent on the amount of benefit that the Riparian System receives from the above practices.

Project Area:

The program is open to all counties in the state of Kansas. Practices will be installed to protect riparian areas that are adjacent to or inside of a grazing unit where livestock have access to the riparian area.

Benefits:

The RQEI will improve the quality of riparian areas and will serve as a holistic approach to the management of these areas. By decreasing or eliminating livestock contact with these sensitive areas, the program will help to improve surface and groundwater quality by decreasing nutrient and bacteria levels. Protected riparian areas will support more diverse populations of wildlife, promote water quality, and improve environmental aesthetics. Moving watering facilities from riparian areas can help promote more uniform utilization of grazing units and provides returns to the producer through increased animal gains and improved herd health.

Goals:

The primary goals of the RQEI include:

- Decrease livestock contact with surface water to improve surface and groundwater quality. This will be accomplished by helping producers develop new water sources.
- Eliminate livestock contact with surface water by providing alternative watering methods and fencing the riparian area to exclude livestock entirely. (A stream crossing will be permitted as designed by the United States Department of Agriculture, Natural Resources Conservation Service (USDA-NRCS) to allow pastures to be adjoined.)
- Promote the improvement of riparian areas using riparian buffers, multispecies tree plantings, and wetland development to provide greater wildlife habitat value, protect water supplies, and improve aesthetic quality for the producer and the people of Kansas.

Eligibility Requirements:

Enrollment for RQEI will be based upon a project proposal submitted to the DOC through the local Conservation District by the landowner. All proposals must be submitted by _____. Following ranking, cost share will be awarded to the projects that have the greatest environmental impact. All Tier 1 projects will have precedence over Tier 2 projects, Tier 2 projects will have precedence over tier 3 projects. Ranking of projects will be within their Tier category:

- Riparian area must be along an intermittent or perennial stream as noted by the United States Geologic Survey (USGS) quad map. The Riparian area should be adjacent to or part of a grazing unit where livestock have access to the area for water and/or shelter.
- Cropland may be enrolled if it is utilized as part of the grazing management of the operation (stock feeding, cover crop grazing) and where access to riparian areas is unrestricted and can be improved through implementation of conservation practices.
- Land must have sites where eligible practices are deemed needed.
- Lands that have an existing Conservation Reserve Program (CRP) contract or an approved offer with a contract pending are not eligible for the initiative until that contract expires.

Practices:

Potential practices in the Kansas RQEI include:

Tier 3 Practices:

Livestock Pipeline-516, Watering Facility- 614, Pumping Plant- 533, Water Well- 642, Spring Development- 574, Pond- 378, Windbreak/Shelterbelt Establishment- 380, Windbreak Shelterbelt Renovation- 650, Heavy Use Protection- 561.

Tier 2 Practices:

Fence- 382, Stream Crossing- 578, Critical Area Seeding- 342, Access Control-472 (required)

Tier 1 Practices

Riparian Forest Buffer-391, Filter Strip- 393, Wetland Restoration- 657, Wetland Creation- 658, Wetland Enhancement- 659.

Incentives:

Participants in the RQEI will be eligible for cost share in a tiered system:

(1) The simplest objective is to use structural practices that decrease use of riparian areas. These projects will receive 80% cost share up to a landowner limit of \$3500.

(2) It is preferred that projects include practices that exclude livestock from riparian areas and establish new watering sites will receive 80% cost share up to a landowner limit of \$7500. (If an adequate

watering system outside the riparian area is currently in place, the project will still be considered for Tier 2 practices. Only ponds that are fenced will be considered an acceptable watering source) A minimum length of 66' from the top of bank to the fence will be required to decrease pollutants. Livestock must be excluded from the entire length of the riparian area within the tract.

(3) Practices that exclude livestock, establish new watering sites, and increase the diversity and functionality of the riparian area through one or more of the tier 3 practices will receive 80% cost share up to a landowner limit of \$10,000. Participants will also be asked for limited access to the site for field days. (If a watering system is outside the riparian area and the riparian area has been fenced from livestock, the project can be considered for tier 3 practices)

(4) Payments will be based on the county average costs for each item.

Example Projects (see examples at end of proposal):

- 1) A producer enrolls in the RQEI to put a new well, pipeline, and water facility in above the Riparian area and does not want to do any additional work. This producer is eligible for 80% cost share up to a maximum of \$3,500.
- 2) A producer would like to install a pond that will be fenced with a watering facility below it to reduce pressure on the riparian area within the property. This producer is eligible for 80% cost share up to a maximum of \$3,500.
- 3) The Producer would like to install a watering system and fence the riparian area to fully exclude cattle. This producer is eligible for 80% cost share up to a maximum of \$7,500.
- 4) The producer would like to install a watering system, fence the riparian area, and improve the riparian area by planting a riparian buffer between the fence and water body. This producer is eligible for 80% cost share up to a maximum of \$10,000.
- 5) Previously, a producer installed a watering facility but would like to install a fence to keep cattle out of the riparian area. This producer is eligible for 80% cost share up to a maximum of \$7,500.
- 6) Previously, the producer installed a watering facility and fenced his riparian area. He would like to install a wetland in a suitable location. This producer is eligible for 80% cost share up to a maximum of \$10,000.
- 7) A Producer would like to fence out his riparian area and install a watering system, but it would prevent him from grazing or utilizing the opposite side. A stream crossing that meets NRCS specifications can be utilized with the fencing and this producer is eligible for 80% cost share up to a maximum of \$7,500.
- 8) A producer would like to install a Shelterbelt to provide wind cover for livestock. A watering facility is in place in the pasture. This producer is eligible for 80% cost share up to a maximum of \$3,500.
- 9) A producer would like to install a watering facility, fence the riparian area, shape and seed some disturbed areas, plant a riparian forest buffer, and install a wetland in a suitable location. This producer is eligible for 80% cost share up to a maximum of \$10,000.
- 10) A producer winters his animals on a stock field that is adjacent to a riparian area that the livestock have access to. He would like to install a watering system. This producer is eligible for 70% cost share up to a maximum of \$3,500. He decides that he would also be willing to

fence the riparian area off, and therefore is eligible for 80% cost share up to a maximum of \$7,500.

- 11) A producer would like to install a watering facility and fence a riparian area. There is no perimeter fencing. This project is ineligible for the initiative.
- 12) DOC will have a final opinion on unique scenarios and the overall value that can be achieved. This will be determined during the ranking process.

Cost:

Financial assistance will be limited to \$92,000 for the first year of the program and may be expanded depending upon success. A major goal of the program is to address high quality projects that will provide the greatest benefit for the environment, public, and producer.

Introduction

The Kansas Sediment and Nutrient Reduction Initiative is a voluntary incentive program for eligible landowners and operators who enroll in the federal Continuous Conservation Reserve Program (CCRP). The Initiative provides a onetime state incentive payment for establishing the associated conservation practices in the targeted Hydrologic Unit Codes (HUC) 12 areas.

The Initiative targets the improvement of surface water quality by encouraging landowners to establish practices that help decrease sediment and nutrients from entering impaired waterbodies. The filtering facilitated by these practices will help to improve surface and groundwater quality, decrease riparian area erosion, improve wildlife habitat and improve the aesthetic quality of agricultural lands and riparian corridors.

Eligible Areas

1. HUC 12 areas that are within the Lower Republican Watershed and that have been designated as a Tier 1 or Tier 2 HUC 12 area.
2. Areas must meet the basic eligibility criteria for the Conservation Reserve Program (CRP)

See the listing of eligible 12-digit HUCs by County located on page 9-10.

Eligible Practices

Conservation Practice (CP)-8A: Grassed Waterway

- 1) Conditions Where Practice Applies
 - a. Areas where the installation of the practice will permit the safe removal of runoff to a stable outlet without causing erosion or flooding.
 - b. Acres must be eligible for enrollment in CCRP practice code CP-8A.
- 2) Policies
 - a. Incentive Payment
 - i. The state incentive payment will be based on the location within the watershed and will be separate from all Federal payments. Tier 1 Areas will receive a single incentive payment of \$250 per acre. Tier 2 areas will receive a single incentive payment of \$162.50 per acre
 - ii. The entire practice must be within the targeted HUC 12 to be eligible for either incentive payment.
 - b. Haying and Grazing
 - i. The seeded acreage should not be hayed or grazed during the lifespan of the CRP contract, unless authorized by the Farm Service Agency (FSA).
- 3) Maintenance
 - a. All acres shall be maintained as specified in the CCRP contract for the life of the FSA contract period.

CP-9: Shallow Water Areas for Wildlife

1) Conditions Where Practice Applies

- a. Areas that can provide a source water for wildlife for the majority of the year with an average depth of 6-18 inches. Exceptions shall be allowed in accordance with FSA 2-CRP.
- b. Acres must be eligible for enrollment in CCRP practice code CP-9.

2) Policies

- a. Incentive Payment
 - i. The state incentive payment will be based on the location within the watershed and will be separate from all Federal payments. Tier 1 Areas will receive a single incentive payment of \$250 per acre. Tier 2 areas will receive a single incentive payment of \$162.50 per acre
 - ii. The entire practice must be within the targeted HUC 12 to be eligible for either incentive payment.
- b. Haying and Grazing
 - i. The seeded acreage should not be hayed or grazed during the lifespan of the CRP contract, unless authorized by the Farm Service Agency (FSA).

3) Maintenance

- a. All acres shall be maintained as specified in the CCRP contract for the life of the FSA contract period.

CP-21: Filter Strips

1) Conditions Where Practice Applies

- a. Areas where the installation of the practice will prevent nutrients, sediment, organic matter, pesticides, and other pollutants carried in runoff from entering surface water bodies.
- b. Acres must be eligible for enrollment in CCRP practice code CP-21.

2) Policies

- a. Incentive Payment
 - i. The state incentive payment will be based on the location within the watershed and will be separate from all Federal payments. Tier 1 Areas will receive a single incentive payment of \$250 per acre. Tier 2 areas will receive a single incentive payment of \$162.50 per acre
 - ii. The entire practice must be within the targeted HUC 12 to be eligible for either incentive payment.
- b. Haying and Grazing
 - i. The seeded acreage should not be hayed or grazed during the lifespan of the CRP contract, unless authorized by the Farm Service Agency (FSA).

3) Maintenance

- a. All acres shall be maintained as specified in the CCRP contract for the life of the FSA contract period

CP-22: Riparian Forest Buffer

- 1) Conditions Where Practice Applies
 - a. Areas where the installation of the practice will prevent nutrients, sediment, organic matter, pesticides, and other pollutants from entering surface water bodies. The practice should also improve habitat quality for aquatic organisms by decreasing temperature and by providing detritus for aquatic and terrestrial organism use.
 - b. Acres must be eligible for enrollment in CCRP practice code CP-22.
- 2) Policies
 - a. Incentive Payment
 - i. The state incentive payment will be based on the location within the watershed and will be separate from all Federal payments. Tier 1 Areas will receive a single incentive payment of \$250 per acre. Tier 2 areas will receive a single incentive payment of \$162.50 per acre
 - ii. The entire practice must be within the targeted HUC 12 to be eligible for either incentive payment.
 - b. Haying and Grazing
 - i. The seeded acreage should not be hayed or grazed during the lifespan of the CRP contract, unless authorized by the Farm Service Agency (FSA).
- 3) Maintenance
 - a. All acres shall be maintained as specified in the CCRP contract for the life of the FSA contract period

CP-23: Wetland Restoration

- 1) Conditions Where Practice Applies
 - a. Areas where the functions and values of a wetland ecosystem can be restored from the previous agricultural use. The level of restoration shall be determined by the producer in consultation with an appropriate technical service provider.
 - b. Acres must be eligible for enrollment in CCRP practice code CP-23.
- 2) Policies
 - a. Incentive Payment
 - i. The state incentive payment will be based on the location within the watershed and will be separate from all Federal payments. Tier 1 Areas will receive a single incentive payment of \$250 per acre. Tier 2 areas will receive a single incentive payment of \$162.50 per acre
 - ii. The entire practice must be within the targeted HUC 12 to be eligible for either incentive payment.
 - b. Haying and Grazing
 - i. The seeded acreage should not be hayed or grazed during the lifespan of the CRP contract, unless authorized by the Farm Service Agency (FSA).
- 3) Maintenance
 - a. All acres shall be maintained as specified in the CCRP contract for the life of the FSA contract period

CP-27: Improvements to Farmable Wetlands

1) Conditions Where Practice Applies

- a. Areas where the functions and values of a wetland ecosystem can be restored from the previous agricultural use. Hydrology and vegetation must be restored to the maximum extent possible, as determined by the United States Department of Agriculture (USDA).
- b. Acres must be eligible for enrollment in CCRP practice code CP-27.

2) Policies

- a. Incentive Payment
 - i. The state incentive payment will be based on the location within the watershed and will be separate from all Federal payments. Tier 1 Areas will receive a single incentive payment of \$250 per acre. Tier 2 areas will receive a single incentive payment of \$162.50 per acre
 - ii. The entire practice must be within the targeted HUC 12 to be eligible for either incentive payment.
- b. Haying and Grazing
 - i. The seeded acreage should not be hayed or grazed during the lifespan of the CRP contract, unless authorized by the Farm Service Agency (FSA).

3) Maintenance

- a. All acres shall be maintained as specified in the CCRP contract for the life of the FSA contract period

CP-28: Farmable Wetland Buffers

1) Conditions Where Practice Applies

- a. Areas where the installation of the practice will prevent nutrients, sediment, organic matter, pesticides, and other pollutants from entering CP-27, Farmable Wetlands.
- b. Acres must be eligible for enrollment in CCRP practice code CP-28.

2) Policies

- a. Incentive Payment
 - i. The state incentive payment will be based on the location within the watershed and will be separate from all Federal payments. Tier 1 Areas will receive a single incentive payment of \$250 per acre. Tier 2 areas will receive a single incentive payment of \$162.50 per acre
 - ii. The entire practice must be within the targeted HUC 12 to be eligible for either incentive payment.
- b. Haying and Grazing
 - i. The seeded acreage should not be hayed or grazed during the lifespan of the CRP contract, unless authorized by the Farm Service Agency (FSA).

3) Maintenance

- a. All acres shall be maintained as specified in the CCRP contract for the life of the FSA contract period

CP-31: Bottomland Hardwood Tree Establishment

- 1) Conditions Where Practice Applies
 - a. Areas where the installation of this practice on wetlands will yield significant and multipurpose land and wildlife benefits.
 - b. Acres must be eligible for enrollment in CCRP practice code CP-31.
- 2) Policies
 - a. Incentive Payment
 - i. The state incentive payment will be based on the location within the watershed and will be separate from all Federal payments. Tier 1 Areas will receive a single incentive payment of \$250 per acre. Tier 2 areas will receive a single incentive payment of \$162.50 per acre
 - ii. The entire practice must be within the targeted HUC 12 to be eligible for either incentive payment.
 - b. Haying and Grazing
 - i. The seeded acreage should not be hayed or grazed during the lifespan of the CRP contract, unless authorized by the Farm Service Agency (FSA).
- 3) Maintenance
 - a. All acres shall be maintained as specified in the CCRP contract for the life of the FSA contract period

CP-33: Upland Bird Habitat Buffer

- 1) Conditions Where Practice Applies
 - a. Areas where the installation of the practice will provide cover, nesting, and food resources for targeted upland bird species.
 - b. Acres must be eligible for enrollment in CCRP practice code CP-33.
- 2) Policies
 - a. Incentive Payment
 - i. The state incentive payment will be based on the location within the watershed and will be separate from all Federal payments. Tier 1 Areas will receive a single incentive payment of \$250 per acre. Tier 2 areas will receive a single incentive payment of \$162.50 per acre
 - ii. The entire practice must be within the targeted HUC 12 to be eligible for either incentive payment.
 - b. Haying and Grazing
 - i. The seeded acreage should not be hayed or grazed during the lifespan of the CRP contract, unless authorized by the Farm Service Agency (FSA).
- 3) Maintenance
 - a. All acres shall be maintained as specified in the CCRP contract for the life of the FSA contract period

Enrollment Process

The Division of Conservation (DOC) will enter into a single contract with the landowner to incentivize participation in the FSA Continuous CRP. The state contract lifespan will coincide with that of the FSA contract, using the FSA contract starting and end date. A cutoff day for current year fiscal year signups will be May 15th, with all subsequent applications rolling into the next fiscal year. The following are the steps in the enrollment process.

1. Interested producers submit application for an eligible CCRP practice and complete an application for Kansas Sediment and Nutrient Reduction Initiative with Conservation District Staff. A copy of this application should be forwarded to DOC.
2. Once signed and completed, the District Manager should acquire the complete and approved CRP-1 (1C) from FSA and enter the following information as Project Information under Step 2 in Cost share Information System (CSIMS):
 - a. CCRP federal contract number.
 - b. Contract federal rental payment less the maintenance amount.
 - c. Contract start date.
 - d. Contract end date.
 - e. Contract acres - Acres may be greater on the state contract due to eligible unfarmable field acres.
3. Copy of completed CRP-1 (1C) is sent to DOC.
4. Funds allocated to the county based on the information in the CRP-1 (1C).
5. Contract is approved electronically by DOC.
6. Conservation District staff print and acquire signatures on the CS-3 and Landowner Agreement.
7. The Conservation District submits the contract for final payment CS-4.
8. Payment is issued by DOC upon approval of the CS-4.

Incentive Payments

1. The DOC shall approve the Final Payment CS-4, which initiates the State of Kansas (SOK)

to send payment directly to the program participants.

- a. Final payments will be made on or before June 1.
- b. Payments will be issued following the approval of the Final Payment CS-4 by the DOC.

Filing Procedures

The following are mandatory Kansas Sediment and Nutrient Reduction Initiative filing procedures for Contract Files maintained at the conservation district office.

1. Option 1 (DOC preferred)

- a. Set up three-ring binder specifically for the Kansas Sediment and Nutrient Reduction Initiative, labeled “Sediment and Nutrient Reduction Initiative Book 1 (and the applicable contract program years).” Multiple fiscal years should be included in the binder until the binder is full at which time a second binder should be started and labeled “Sediment and Nutrient Reduction Initiative Contracts Book 2 (and the applicable program years).” Separate fiscal years with a large divider labeled for the applicable fiscal year.
- b. Contracts should be filed in alphabetic order by primary landowner’s last name, by fiscal year.
- c. Each contract should have the following information filed with it, in the following order:
 - i. Copy of aerial photo map of property, with the practice location clearly marked.
 - ii. Copy of approved Federal CRP-1 (1C) Conservation Reserve Program Contract.
 - iii. CS-3 “Application/Contract for Financial Assistance.”
 - iv. Amended CS-3, when applicable.
 - v. Cancelled CS-3, when applicable.
 - vi. Final Payment CS-4 signed by (FSA,NRCS?)
 - vii. Other documents as applicable.
 - viii. Each contract should be separated by a divider.

2. Option 2

Maintain the above information in a file folder, labeled with contract number, primary landowner name, and program year of contract approval. File in alphabetical order by primary landowner's last name.

Administering Agencies

1. The Conservation District is responsible for enrollment and implementation of the Initiative at the local level.
2. The Division of Conservation (DOC), Kansas Department of Agriculture (KDA) is responsible for the administrative rules, regulations, guidelines, and procedures. DOC will approve all contracts, and payments.
3. The USDA Natural Resources Conservation Service (NRCS) provides technical assistance in the design, layout, certification, and enrollment of the associated practices for federal CRP contracts through the Continuous Conservation Reserve Program. All practices must meet NRCS Field Office Technical Guide Standards and Specifications.
4. Other state and federal agencies also play a key role in administration and support of the program including but not limited to USDA Farm Service Agency (FSA), Kansas Department of Wildlife, Parks, and Tourism (KDWPT), and Kansas Department of Health and Environment (KDHE).

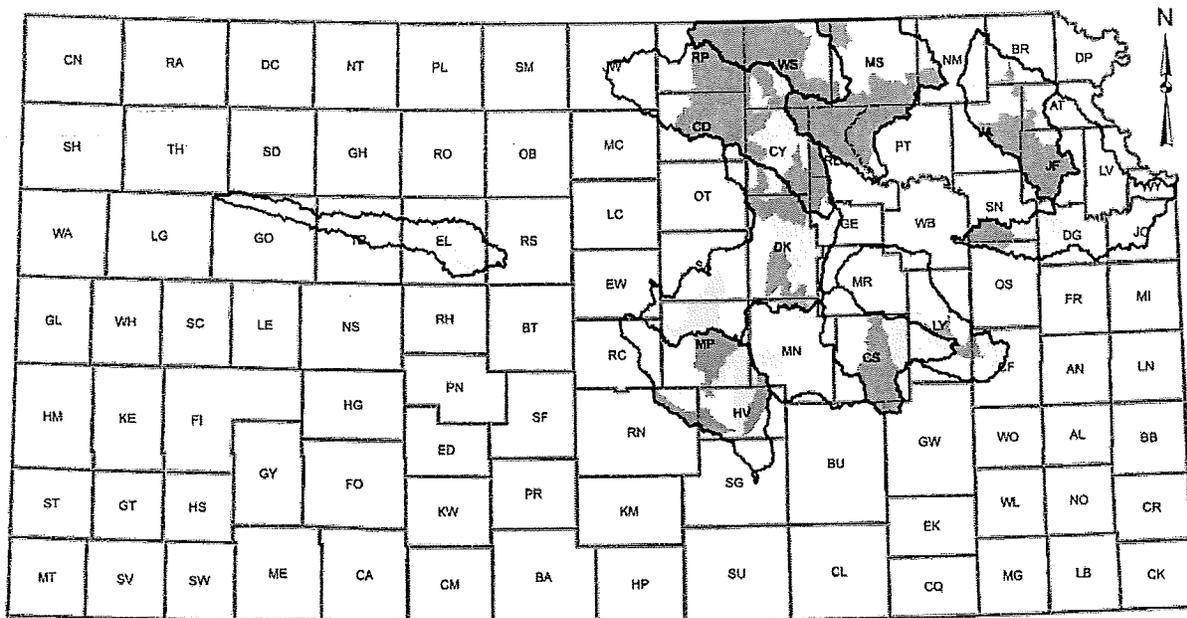

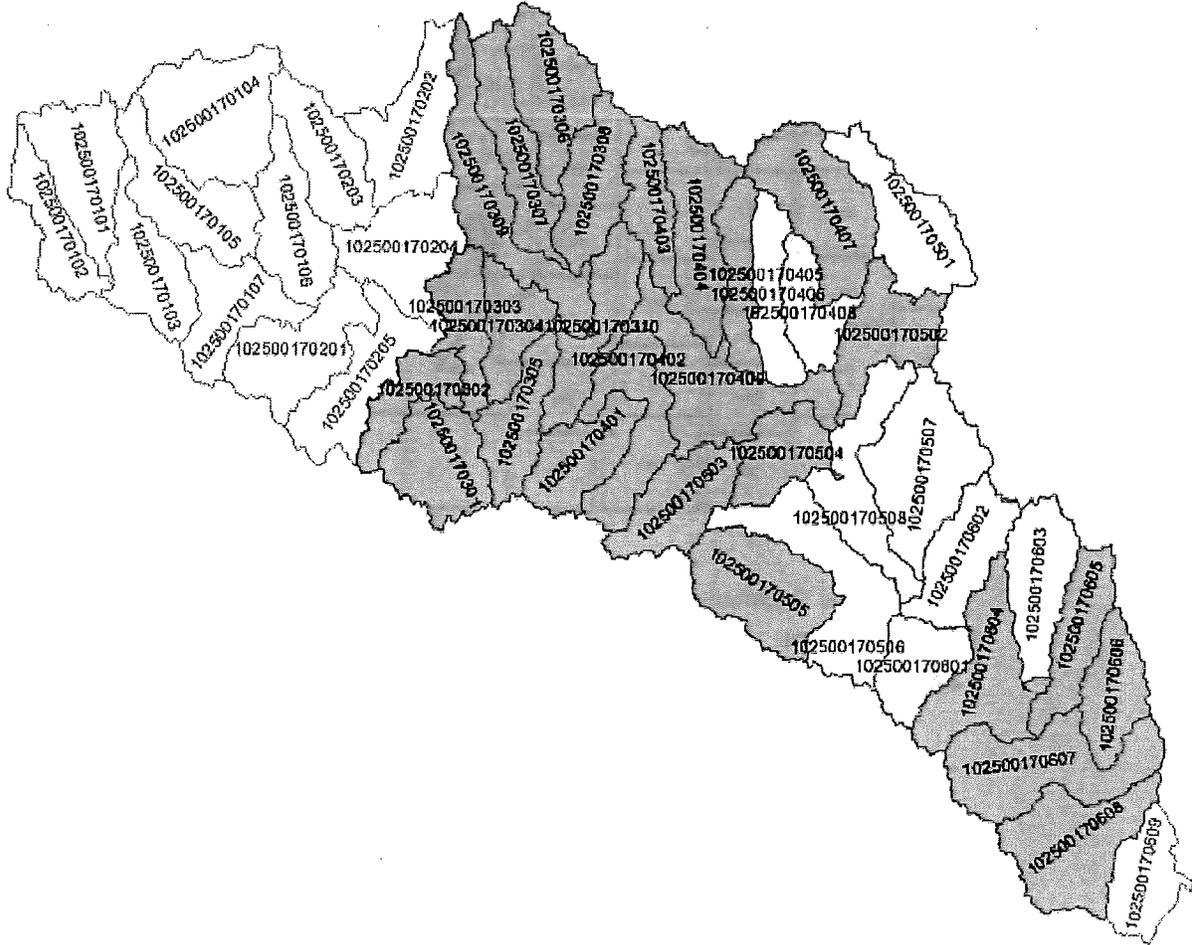

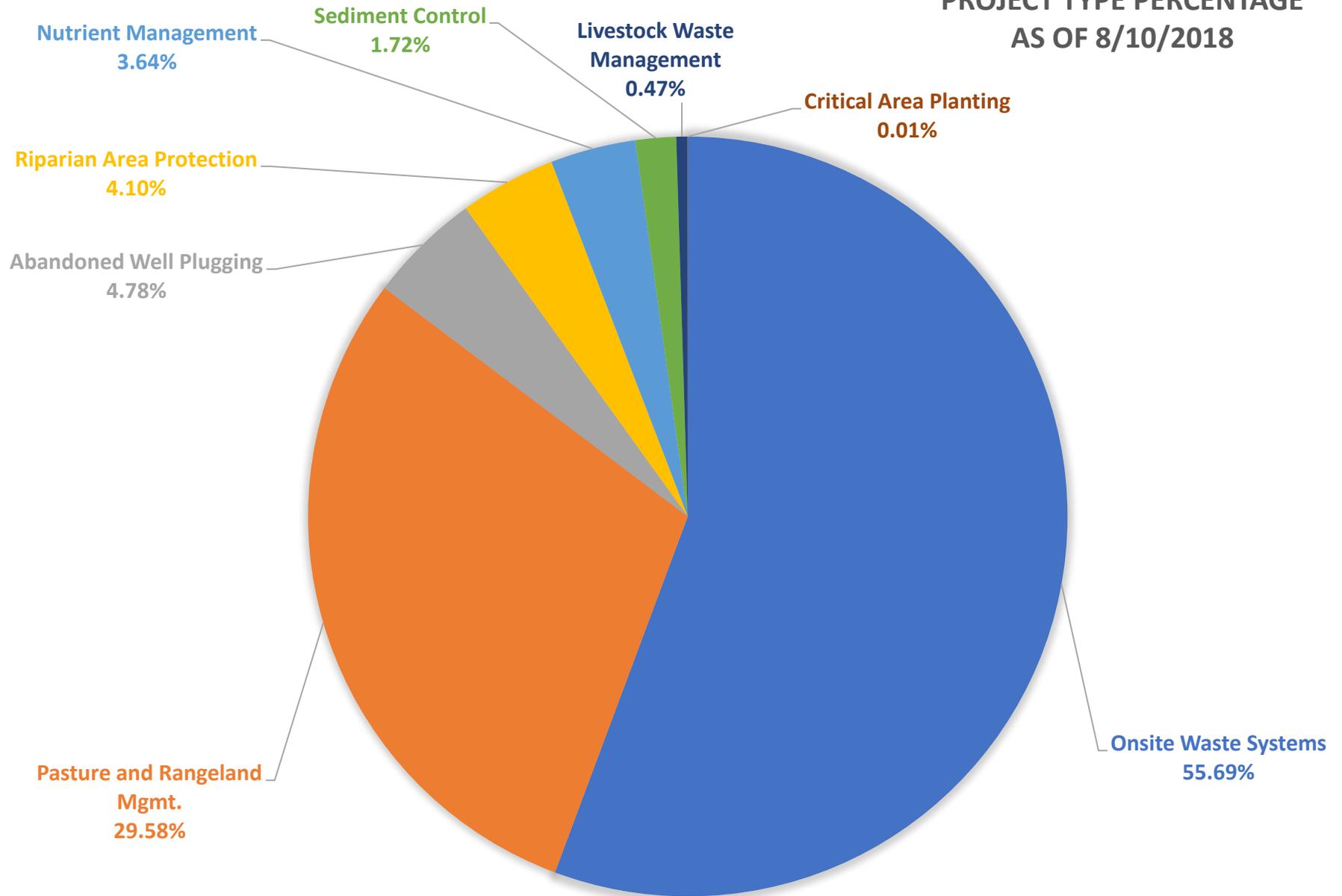

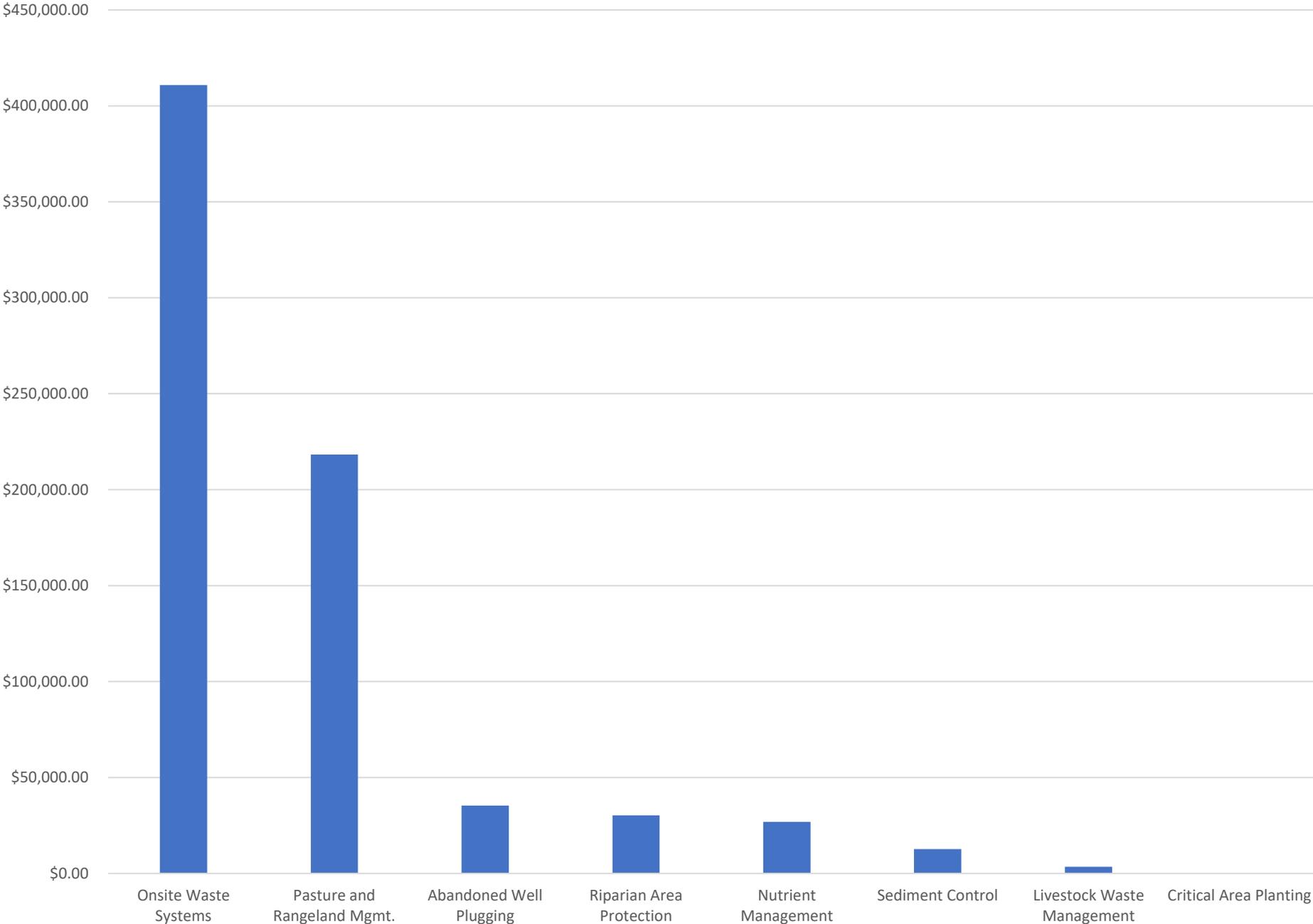
FY 2018 NPS PAID CONTRACTS

AS OF 8/10/2018



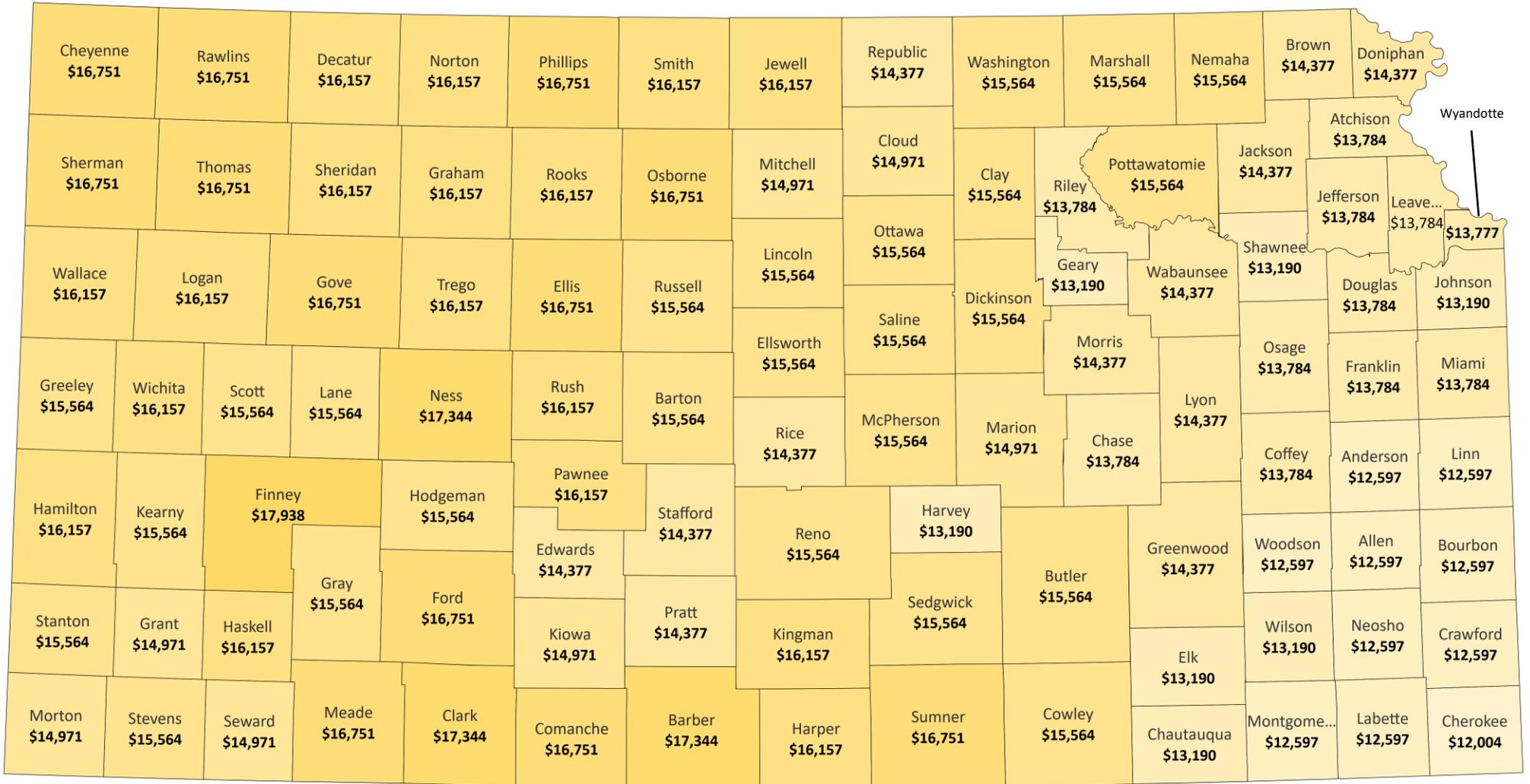

- Counties have not received state funding for these LEPP programs since 2012. Sanitary code enforcement is currently funded by each individual county.

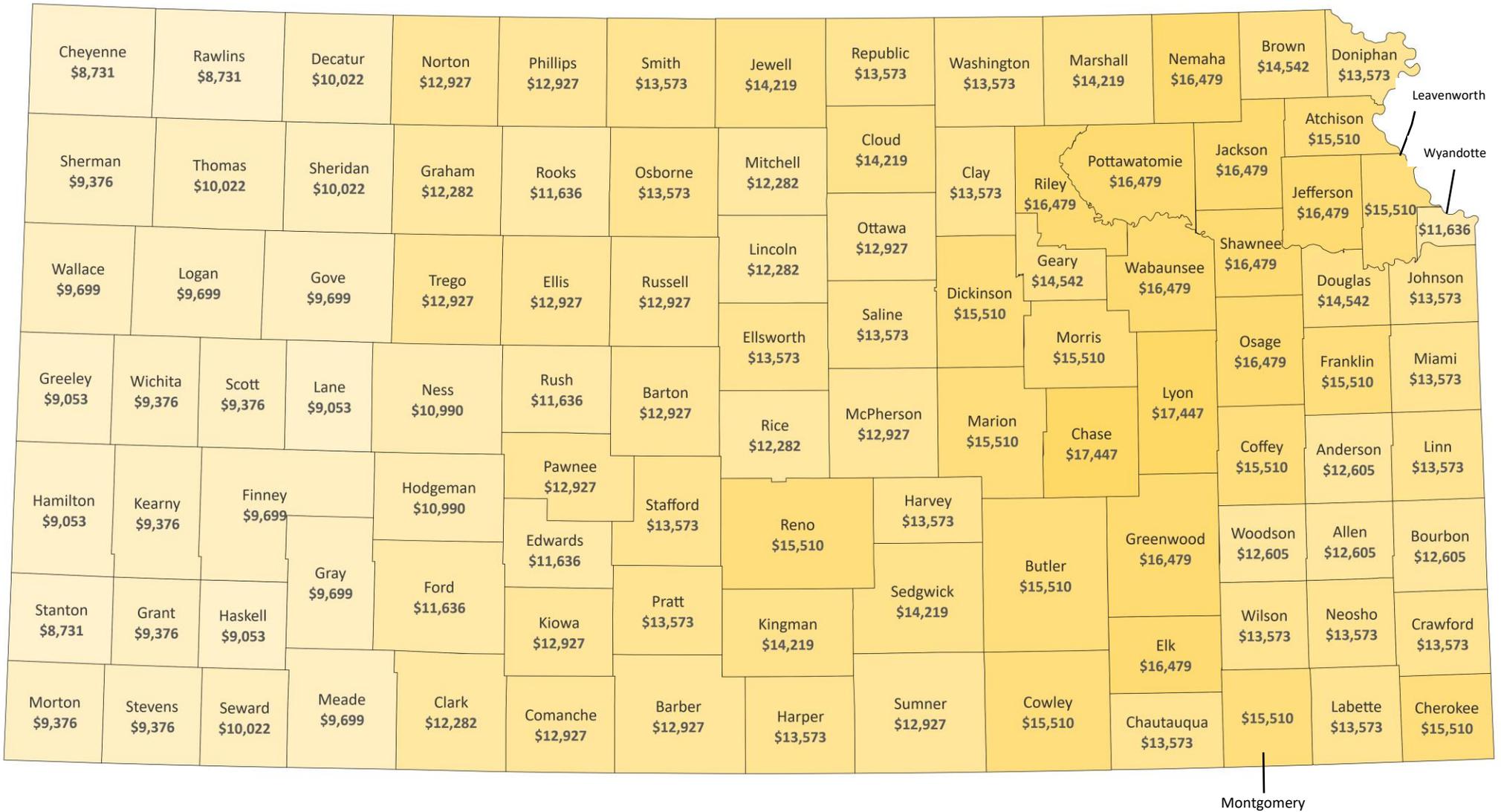

FY 2019 WR Allocations \$1,581,392 Total

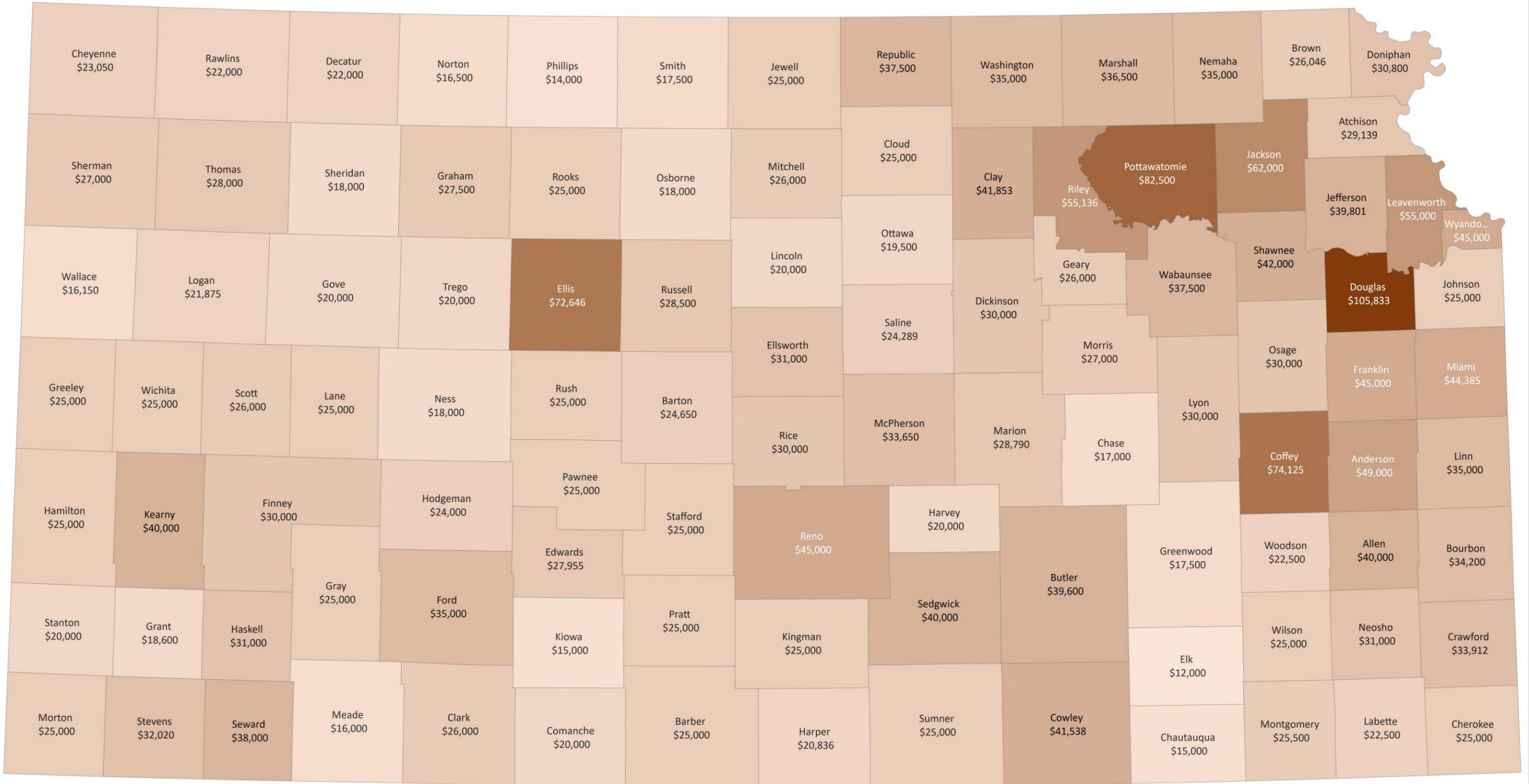


FY 2019 NPS Allocations

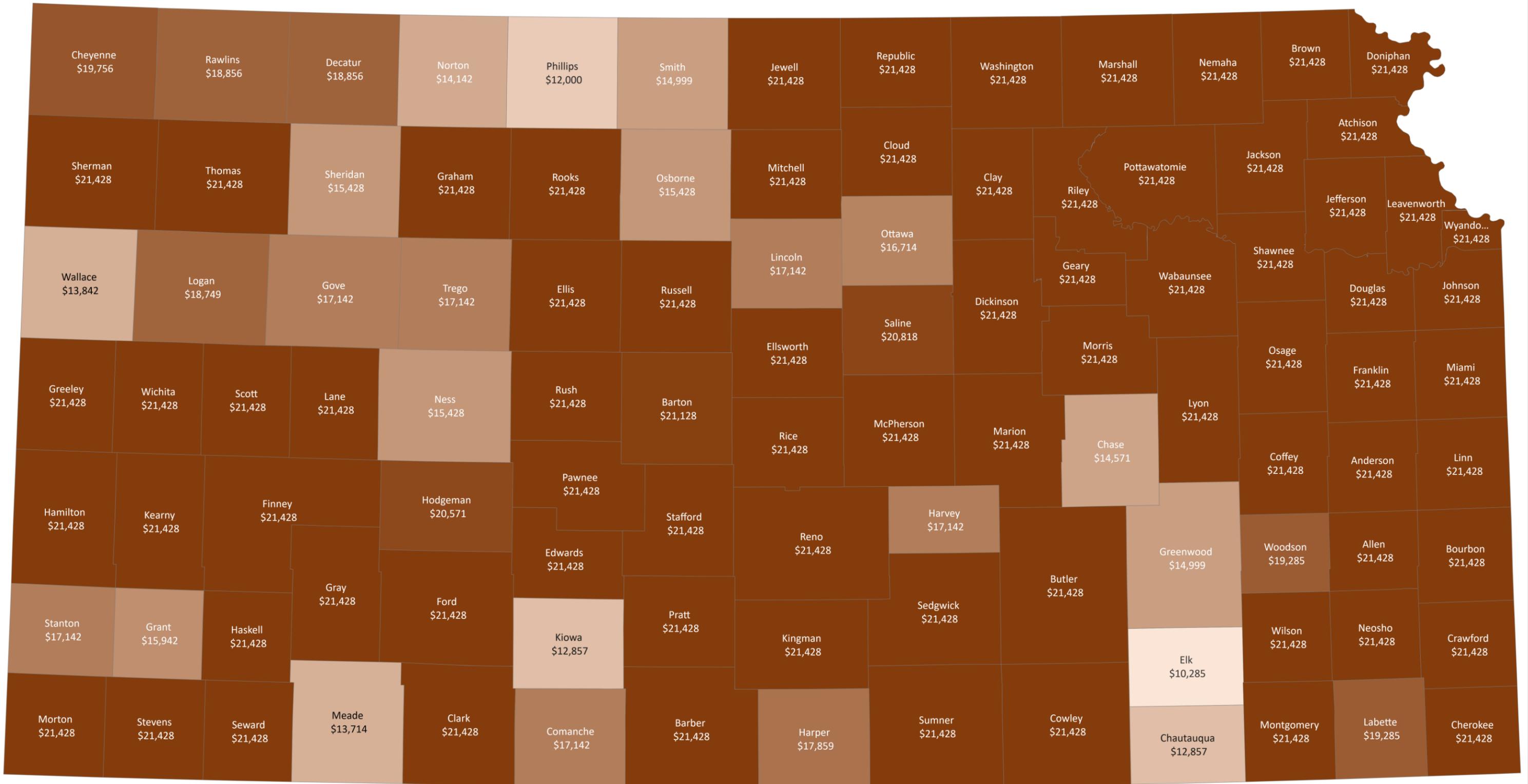

FY 2019 County Budget Allocation to Conservation Districts



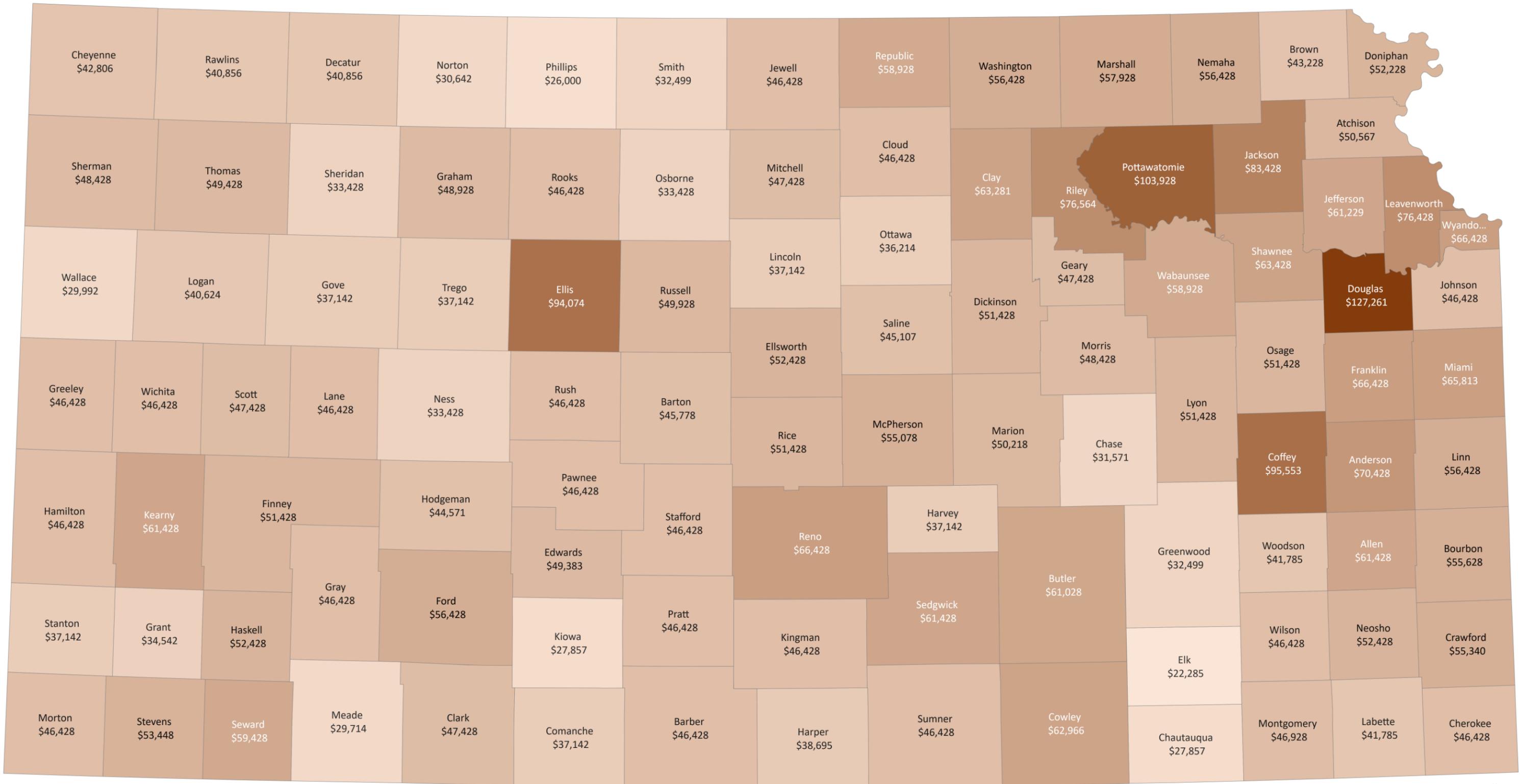
FY 2019 State Aid to Conservation Districts
