GUIDELINES  
Pesticide Business Licensee's Surety Bond

These guidelines are provided to assist in the preparation and submission of acceptable surety bonds. These guidelines, if followed, will allow the surety bond to be processed efficiently and expeditiously.

1. The bond must be on the Kansas Department of Agriculture form entitled, "Pesticide Business Licensee's Surety Bond".
2. The surety bond submitted shall provide bond coverage of **not less than \$6,000** per year.
3. The **corporate surety must be a company that is authorized by the Kansas Insurance Department to transact such business in Kansas.**
4. The **principal's name should match the business name furnished by the applicant on the pesticide business license application.**
5. **The city and state address of the principal must be on the bond. To be timely processed, the information should match that shown in the Kansas Department of Agriculture records as submitted by the applicant.** (Regulation 4-13-9 requires the business to notify the Kansas Department of Agriculture, in writing, of any change in the business address.)
6. The bond shall be effective for **a period not to exceed one year and shall extend to December 31 of the licensing year.**
7. The "witness our hands" portion of the **bond must be completed with the appropriate day, month, and year.**
8. **The principal must sign** the bond.
9. **The surety must sign** the bond.
10. The **surety's power-of-attorney statement is to be attached to the bond.**
11. If **the principal is a corporation which has a seal, the seal should be affixed** in the area of the bond designated for corporate seal of principal.
12. If the **corporate surety has a seal, the seal should be affixed** to the bond in the area designated for the corporate surety seal.
