OPERATIONS

The Cooperative Agreements are progressing with 14 soil conservation technicians (SCTs) and four Pheasants Forever (PF) biologists being planned. PF biologists should start around March 1, 2010, and the SCTs around July 1, 2010.

Additional global positioning systems (GPS) units are being ordered to replace the remainder of the old units in the field.

NRCS appreciates the conservation district personnel for completing the required computer security training. There were eight employees who were down to the wire in getting it completed with only three not meeting the deadline. Two of those three took computer security training, but took the wrong one. All have now completed the training.

PROGRAMS

Conservation Security Program (CSP)

Obligations for Fiscal Year (FY) 2010 for 2002 CSP (Security) contracts is nearing completion. All payments for these contracts will be completed by February 12, 2010.

Conservation Stewardship Program (CSP)

For 2008 CSP (Stewardship), obligations of eligible applications will be completed by January 30, 2010. Applicants will be notified by mail regarding funding decisions related to their application.

Environmental Quality Incentives Program (EQIP)

The application evaluation period cut-off date has been set for January 15, 2010. There will be a special national initiative for Organic, which will have a different cutoff date. Information for the FY 2010 program can be found at

http://www.ks.nrcs.usda.gov/programs/eqip/2010/index.html. The FY 2010 EQIP allocation is \$18,113,503.

Farm and Ranch Lands Protection Program (FRPP)

Work continues for closing on three FY 2008 conservation easement parcels and one FY 2009 parcel. FRPP is now a continuous signup program and cooperating entities can submit application parcels throughout the year. At the present time no new applications have been submitted for FY 2010 funding consideration. A ranking cutoff date has been set for February 15, 2010, to rank submitted applications.

<u>Grassland Reserve Program (GRP)</u>

The GRP allows for applications to be accepted continuously throughout the year. Application evaluation periods will be used to accumulate applications for subsequent ranking. One application period is currently planned for FY 2010. The application cutoff date for this next evaluation period is close of business January 22, 2010. Kansas NRCS has been working to establish Geographic Rate Caps for the FY 2010 GRP and will be posting these easement offer rates as soon as they are approved by our national headquarters.

American Recovery and Reinvestment Act (ARRA) Stimulus Package

Kansas NRCS continues to work on completion of projects funded under the ARRA. We have four watershed projects that received funding:

- Lyons Creek Site 15 (New Construction) Morris County
- Switzler Creek Site 7 (Rehabilitation) Osage County
- Big Caney Site 18 (Remedial) Cowley County
- Wet Walnut Site 53 (Remedial) Ness County

All permits for construction have been received for Lyons Creek, Big Caney, and Wet Walnut. Project Agreements with the sponsors are now being signed so that bids for construction may be posted. The watershed rehabilitation plan for Switzler Creek was approved by the Chief of NRCS and design work is now underway for the approved federal rehabilitation alternative.

In addition, Kansas received funding under ARRA to enroll three new Emergency Watershed Protection – Floodplain Easements (EWPP-FPE). Work is currently underway to complete legal surveys and title review on these sites. The acres and county location of the three approved sites are:

- Doniphan County 564 acres
- Labette County 48 acres
- Rice County 223 acres

EWPP-FPE easements are required to be closed by February 3, 2010, and restoration is required to be completed by December 31, 2010.

Wetlands Reserve Program (WRP)

FY 2009 ended with 18 new enrollments on 2,820 acres. All boundary surveys pertaining to these new enrollments have been completed. One FY 2009 enrollment has closed and three additional easements are poised to close in the near future. Twenty-five new applications have been received since October 1. Field visits are being scheduled to be able to rank and approve applications by February 19, 2010. New Geographic Area Rate Caps (GARCs) were reviewed by the State Technical Committee and recommended to the State Conservationist. The FY 2010 GARCs were submitted to national headquarters and approved for use in FY 2010. Offers to purchase are now being made to current eligible applications.

Wildlife Habitat Incentives Program (WHIP)

The application evaluation period cut-off date has been set for January 15, 2010. FY 2010 program information has been provided to the field offices. Additional information regarding the FY 2010 program can be found at http://www.ks.nrcs.usda.gov/programs/whip/2010/index.html. The FY 2010 WHIP allocation is \$317,179.

TECHNOLOGY

We are managing our agreement with the State Conservation Commission (SCC) and their contractor, The Watershed Institute (TWI), to get streambank projects designed and built. Designs have been completed for four more of the 2008 projects. Construction on eight projects is awaiting an improvement in the weather, and these projects should be built by this spring. High water in the rivers has delayed the surveys of the last four projects. Those surveys should be completed this winter.

The design of a group of six 2008 EQIP projects had been sent out for bid by the SCC, and work on those projects should begin soon. This group of projects will be designed by Wildhorse Riverworks, Inc.

Reno/Sparks, Nevada, recently hosted the 4th National Conference for Grazing Lands, December 13-16, 2009. The conference is intended to be a forum for producers, landowners, land managers, and grazing land professionals where success stories, experience, and questions can be asked, discussed and debated. Unlike many national conferences, a strong push for producer involvement is a primary focal point. Producers, local grazing groups from states, and grazing land leaders present and host breakout sessions providing for an opportunity to ask and answer questions. This year a small contingent from Kansas presented a 1.5 hour session on the grazing lands of Kansas. Information was presented by the Tall-grass Legacy Alliance, Comanche Pool Foundation, Playa Lakes Joint Venture, United States Fish and Wildlife Service, and the Natural Resources Conservation Service. Approximately 900 people were in attendance.

Outreach Survey on NRCS SharePoint

The new Kansas Outreach Survey had 97 responses in the 1st quarter. Outreach reports are now collected electronically and can be reported immediately rather than on a form that was due at the end of a fiscal year. This is great response for a quarter and there were a variety of events reported, and the report shows that lots of people were informed and/or took part in the events. NRCS and conservation districts worked with grassroot organizations; school children; adults; Survey showed people of diverse ethnic backgrounds were provided outreach.
