Regional Conservation Partnership Program (RCPP)

- Kansas had 3 project proposals selected for funding and is in the process of negotiating and formalizing agreements with the lead partners for the following selected proposals:
 - o Improving Water Quality through the Implementation of Forestry Practices and the Assessment of Riparian Systems in Kansas Priority Watersheds
 - Project Scope: Watershed assessments and Water Quality improvement in selected Kansas watersheds utilizing forest stand improvement and tree planting practices.
 - Participating States: Kansas
 - Lead Sponsor: Kansas State University
 - NRCS Offer: \$13,000,000
 - o Kansas Pheasant Initiative
 - Project scope: Pheasant habitat improvement utilizing cover crops in dryland crop rotations in targeted areas surrounding Keith Sibelius and Waconda Lakes.
 - Participating States: Kansas
 - Lead Sponsor: Kansas Department of Wildlife, Parks, and Tourism
 - NRCS Offer: \$800,000
 - o Advanced Irrigation Water Management on the High Plains Aquifer in Kansas
 - Project Scope: Installation of irrigation water monitoring equipping to achieve real time irrigation water management scheduling in all GMD areas of the High Plains Aquifer.
 - Participating States: Kansas
 - Lead Sponsor: Southwest Kansas Groundwater Management District 3
 - NRCS Offer: \$2,400,000
 - Kansas is a part of 2 other proposals where other states are negotiating and formalizing agreements with project sponsors.
 - o Regional Grassland Bird and Grazing Lands Enhancement Initiative
 - Participating States: Missouri, Nebraska, Kansas, Iowa
 - Lead Sponsor: The Missouri Department of Conservation
 - NRCS Offer: \$5,000,000
 - o Middle and Lower Neosho River Basin RCPP Project.
 - Participating States: Oklahoma, Kansas
 - Lead Sponsor: Oklahoma Conservation Commission Water Quality Division
 - NRCS Offer: \$4,000,000
 - Mechanisms to deliver project assistance and funds will be developed and established as soon as project agreements have been formalizes and signed.
 - NRCS will announce the next round of RCPP funding availability soon.

TECHNOLOGY

OUTREACH

Kansas NRCS announced five national initiatives are being offered in Kansas through the Environmental Quality Incentives Program (EQIP): Lesser Prairie-Chicken Initiative, National Water Quality Initiative, On-Farm Energy Initiative, Organic Initiative, and Seasonal High Tunnel Initiative. While NRCS accepts applications for EQIP on a continuous basis, NRCS has set a deadline of March 20 to apply for the initiatives.

Applications are being accepted for up to \$20 million in grants to facilitate the creation of new, innovative markets for carbon credits, providing additional revenue sources for producers to use to address natural resource conservation challenges. These grants are part of the Conservation Innovation Grants (CIG) program, authorized through the 2014 Farm Bill. NRCS will accept pre-proposals for initial review before inviting entities to submit full proposals. Pre-proposals are due Tuesday, February 24, 2015.
