



In addition, I consider the water rights held by irrigators to be a property right and development of the LEMA with limited data could result in unnecessary regulation and reduction of water rights, which in turn could have a serious negative impact on the value of the owner's property rights.

I feel the intent of the LEMA law was to provide local solutions for local problems. By implementing a GMD #4 wide LEMA, I question how local the proposed LEMA truly is and how well the reductions are tailor made to correct a local neighborhood problem.

Also, I would like to point out there is a significant difference as you travel across the GMD #4 and the proposed LEMA area. The elevation increases as you move from east to west. The elevation north of Hill City, at the east side of the proposed LEMA is 2,300' and as you move west the elevation increases to 2,725' at Hoxie and on up to 3,970' at the Kansas/Colorado line near Kanorado.

The growing season increases as you move from west to east with a 155 average day growing season in Sherman County, a 160 average day growing season in Thomas County, a 163 average day growing season in Sheridan County and 167 average day growing season in Graham County.


Rainfall across the GMD #4/Proposed LEMA also changes from west to east with the 1981-2010 average of 19.84" in Sherman County to 20.43" in Thomas County, to 20.8" in Sheridan County and up to 21.9" in Graham County. These changes have a strong affect on farming operations in the different areas of the GMD #4/Proposed LEMA. These differences are significant when you evaluate the change from the west side of the GMD #4/Proposed LEMA to the east side of the GMD #4/Proposed LEMA. Farm operators/irrigators in Sherman County have to implement different farming practices than the farm operators/irrigators at the east side in Graham County to adapt to these changing conditions.

These factors which affect growing season and growing conditions, should have been taken into consideration and I feel would have been best to have identified smaller local LEMAs that could deal with local identified water declines with locally developed regulations.

I must note that I find the farmers across the GMD #4/Proposed LEMA to be progressive, up to date farmers that deal with the local conditions they are exposed to, but I must note that what a farmer can do in the east portion or the central portion of GMD #4/Proposed LEMA is significantly different than the farmer operating at the west side of the GMD #4/Proposed LEMA.

I am very concerned about approval of the Local Enhanced Management Area (LEMA) plan proposed by the Northwest Kansas Groundwater Management District No. 4. I respectfully request that you not approve it, at least until the GMD provides more detailed information to irrigators.

The GMD-4 Board is attempting to make the entire GMD-4 into a LEMA much like the LEMA-6 was formed, but they have ignored three major considerations.

1. They did not accept suggestions from the producers involved. They held meetings, but did not consider any of the suggestions.
2. The board came up with a plan by township, rather than on an individual well basis. (Look at the well concentration on LEMA-6 compared to the well concentration east of Highway 23. The area east of Hwy 23 needs to be on a "per well" basis, as the wells in this area are much farther apart.)
3. The board assumed the growing conditions and thus the irrigation practices from the Hill City area, Graham County, to the Colorado border, the same. Elevation, (growing season length), and rainfall the same? Both are important.


I am the Trustee for the A.L. Abercrombie Marital Trust, which owns land in Sheridan County. It includes irrigation wells and water rights that are used to irrigate approximately 885 acres under sprinkler irrigation in Northeast Sheridan County. The A.L. Abercrombie Marital Trust sprinkler irrigated cropland is operated by a local farm tenant. The local farm tenant and I take the use of the irrigation water very seriously and I expect the tenants to monitor the operation closely on an ongoing basis. Our goal is to be good stewards of the land and water rights owned by the A.L. Abercrombie Marital Trust.

In reviewing the data obtained from the limited number of monitoring wells utilized to determine the static water level across GMD #4, I question why additional information and additional monitoring sites were not used. When we redrilled an irrigation well a few years ago, the Division of Water Resources (DWR) required an inspection tube to be placed next to the well casing. I question why additional measuring sites were not utilized because it does appear they were available.

The A.L. Abercrombie Marital Trust irrigated cropland is located east of Highway 23 in Northeast Sheridan County. A review of the GMD #4 colored township map that was developed for the proposed District Wide LEMA, indicates that our irrigation wells and much of the area in the GMD #4 east of Highway 23 is in the blue and green colored townships which indicate **0% to 0.5% for average annual decline**. With this in mind, I question why the proposed LEMA was "a district wide LEMA proposal". I feel locally identified areas, with locally developed guidelines, would have been a more accurate way of dealing with local problems.

Taking into consideration the limited number of measurement wells utilized in the proposal, I oppose the approval of the proposed Local Enhanced Management Area (LEMA) and encourage you to deny the application and return it to the Groundwater Management District #4 for additional research and development.

I worked for the Soil Conservation Service/ Natural Resources Conservation Service for almost 31 years before retiring. Part of my career was spent in the irrigation field. I will go on record as supporting the GMD4 proposed LEMA.

Mr. Traester brought up the issue of fairness a lot when he had Ray Luhman on the stand. It isn't fair to be on one side of the line or the other. In all the programs I worked with in my career lines were drawn. Lines on a map had to be drawn for eligibility for programs, Highly Erodable line for soil map units, HUC codes or political boundaries. When a new program or proposal like the proposed LEMA is draw up lines have to appear on a map.

At the hearing is was brought up a lot that information was hard to get. I have attended monthly GMD4 board meetings for a while. At every meeting that the LEMA was discussed there was a handout. GMD4 staff made sure everyone that wanted a copy got one. In the handout the changes were highlighted. The information was readily available for those that wanted it. The date and time of the monthly meetings are posted on the GMD4 website which is available to anyone that can google.

I will respond to the appraiser comments about reducing property values. I know of two circles that sold recently in Sheridan county. The legal descriptions of the land are the SE4 15-8-28 and the is the NE 22-8-29. Both quarters have center pivots on them. One was inside the SD 6 LEMA boundaries. The other one was not. They are right across the road from each other. The water is about the same on both circles. Very similar soils as well. The both sold for the same money.






We are opposed to the Local Enhanced Management Area (LEMA) plan proposed by the Northwest Kansas Groundwater Management District No.4.

We own three irrigation circles in Thomas County, Kansas that are within the boundaries of the Northwest Kansas Groundwater Management District No.4. Our most recent purchase was in 2015 for a circle that was close to our farming headquarters that had a strong pumping well. We paid a **significant premium** for this parcel because it had such a strong well that was capable of fully utilizing the total acre-feet associated with its water right. We expected to grow high yield corn because of the amount of water the well could pump, and was allowed to pump.

The proposed LEMA appears to arbitrarily reduce our annual pumping limit to 15.4" which is **significantly less** than what the water right allows and what the well is capable of pumping. I believe the LEMA plan to reduce pumping from this well is a taking of our property right. It not only reduces the value of the land that we recently purchased, but prevents us from consistently growing the high yield corn that we anticipated when we purchased the circle.

Because our crop yields will decline due to the LEMA's requirement to pump less water, the revenue generated from this circle may not cover the debt service associated with the loan. Where does that leave my family? Retroactively limiting the ability to use a water right within a few years of purchasing the land with the water right doesn't seem reasonable or fair. The LEMA should not impact a landowner's ability to service debt and make a reasonable living of their land.

We are strongly opposed the LEMA.
