**Minnesota Reciprocal Certification Requirements**

**This form does not replace the commercial pesticide applicator certification application.**

The following conditions apply to each applicant who wishes to obtain commercial pesticide applicator certification in Kansas based on the Reciprocal Agreement between the Minnesota Department of Agriculture and the Kansas Department of Agriculture.

1. Applicant must be 18 years of age.
2. Applicant must be a **resident of Minnesota** and submit a photocopy of their driver’s license with their application.
3. Applicant has taken and **passed the Minnesota** commercial applicator certification examinations.
4. Applicant is a commercial certified applicator and their license is current or applicant is a noncommercial certified applicator and license is current.
5. Applicant’s license has not been suspended or revoked and no enforcement action is currently pending against the applicant.
6. Applicant must submit completed application for commercial pesticide applicator certification.
7. Applicant must pay appropriate fees. The fee to reciprocate from Minnesota to Kansas is **\$75 per category**. The same fees apply for commercial and noncommercial applicators reciprocating from Minnesota. Kansas has a three year certification period, expiring on Dec 31<sup>st</sup> of the third year. Minnesota fees are \$50 plus a \$25 ACCRA surcharge annually.
8. The applicant must be licensed in the following category/subcategory(ies) and will be eligible for certification in Kansas in the corresponding category/subcategory(ies) if all other conditions apply:
