### Missouri Reciprocal Certification Requirements

The following conditions apply to applicants who wish to obtain commercial pesticide applicator certification in Kansas based on the Reciprocal Agreement between Missouri and Kansas:

1. Applicant must be at least 18 years old.
2. Applicant must be a **resident of Missouri**.
3. Applicant has taken and **passed Missouri's** commercial pesticide applicator certification examinations.
4. Applicant is a commercial certified applicator and the license is current. OR  
 Applicant is a noncommercial certified applicator and certification is current.
5. Applicant's certification has not been suspended or revoked and no enforcement action is currently pending against the applicant.
6. Applicant must submit completed application for commercial pesticide applicator certification.
7. Applicant must pay appropriate fees. The fee to reciprocate from Missouri is **\$75 per category**. The same fees apply for commercial and noncommercial applicator reciprocating from Missouri.
8. Applicant must be certified in the following category/subcategory(ies) and will be eligible for certification in Kansas in corresponding category/subcategory(ies) if all other conditions apply:
