Texas Reciprocal Certification Requirements

This form does not replace the commercial pesticide applicator certification application. The following conditions apply to each applicant who wishes to obtain commercial pesticide applicator certification in Kansas based on the Reciprocal Agreement between the Texas Department of Agriculture and the Kansas Department of Agriculture.

- 1. Applicant must be at least 18 years old.
- 2. Applicant has taken and **passed the Texas** commercial applicator certification examinations.
- 3. Applicant is a commercial certified applicator and the license is current <u>or</u> applicant is a noncommercial certified applicator and license is current.
- 4. Applicant's license has not been suspended or revoked and no enforcement action is currently pending against the applicant.
- 5. Applicant must submit completed application for commercial pesticide applicator certification.
- 6. Applicant must pay appropriate fees. The fee to reciprocate from Texas to Kansas is \$75 per category. The same fees apply for commercial and noncommercial applicators reciprocating from Texas. Kansas has a three-year certification period that expires on December 31 of the third year.
- 7. The applicant must be licensed in the following category/subcategory(ies) and will be eligible for certification in Kansas in the corresponding category/subcategory(ies) if all other conditions apply:
