Persons seeking to cultivate or produce industrial hemp must be licensed by the Kansas Department of Agriculture (KDA) as a commercial industrial hemp producer pursuant to K.S.A. 2-3901 et seq. The application deadline for the 2021 growing season was March 15, 2021.
