The last handler is required to pay an inspection fee of \$0.0035 per dozen or a minimum of \$15.00. These fees are to be paid and reported quarterly to the state of Kansas.
- Producer

 Any person who exercises control over the production of eggs and disposes of eggs from the output of a flock owned by such person in accordance with K.S.A. 2-2501. All producers who choose to sell their eggs as graded must obtain an egg license and purchase inspection fee stamps.

APPLICATION FOR PERMIT TO REPORT AND PAY THE  
EGG INSPECTION FEE ON A QUARTERLY BASIS

The undersigned hereby makes application to the Secretary of the Kansas Department of Agriculture for a permit to report and pay on a quarterly basis the egg inspection fee in accordance with the provisions of the Kansas Egg Law.

It is hereby understood and agreed that upon the issuance of a permit the applicant will keep such records as are necessary and as are satisfactory to the said Secretary to indicate accurately the quantity of eggs sold during the period the permit is in force and effect, and on which the inspection fee is due; and will report to said Secretary on the first days of October, January, April and July, or within thirty days thereafter, of each year the quantity of eggs sold on which the inspection fee is due during the preceding three months, and remit therewith the inspection fee thereon. The Secretary of the State Department of Agriculture and his/her duly authorized representatives are hereby granted permission to check the records and otherwise verify the statement of quantity of eggs sold.
