Kansas Department of Agriculture — Certificate of Free Sale www.agriculture.ks.gov	Many countries require a Certificate of Free Sale, sometimes called a "Certificate for Export" or "Certificate to Foreign Governments." The certificate is an assurance that the products listed on the certificate are eligible for export and approved by the regulatory authorities in the country of origin. If your business is looking to obtain a Certificate of Free Sale, please reference this document from the Kansas Department of Agriculture.
Export-Import Bank of the United States (EXIM) www.exim.gov	Export-Import Bank of the United States is the official export credit agency of the United States. When private sector lenders are unable or unwilling to provide financing, EXIM fills in the gap for American businesses by equipping them with the financing tools necessary to compete for global sales. EXIM assumes credit and country risks that the private sector is unable or unwilling to accept.
Food Export-Midwest www.foodexport.org	Food Export-Midwest is a non-profit organization that promotes the export of food and agricultural products for businesses in its 13 Midwestern-state members. The services that they offer include export promotion, customized export assistance and a cost-share funding program. Foreign-Trade Zones (FTZ) www.trade.gov/foreign-trade-zones-board	Foreign-Trade Zones are secure areas under U.S. Customs and Border Protection (CBP) supervision that are generally considered outside CBP territory upon activation. Located in or near CBP ports of entry, they are the United States' version of what are known internationally as free-trade zones. Foreign and domestic merchandise may be moved into zones for operations not otherwise prohibited by law, including storage, exhibition, assembly, manufacturing and processing. Global Agricultural Information Network (GAIN) Reports gain.fas.usda.gov	The Global Agricultural Information Network Reports provide information on the agricultural economy, products and issues in foreign countries that are likely to have an impact on U.S. agricultural production and trade. The USDA Foreign Agricultural Service also publishes the Food and Agricultural Import Regulations and Standards, which includes regulatory and documentary requirements for a market.
Global Agricultural Trade System (GATS) apps.fas.usda.gov/gats	Global Agricultural Trade System includes international agricultural, fish, forestry and textile product trade statistics dating from the inception of the Harmonized coding system to the present.
Harmonized System www.census.gov/foreign-trade	Harmonized System Codes for import/export classification and statistical purposes. The Schedule B is administrated by the U.S. Census Bureau.
Harmonized Tariff System dataweb.usitc.gov	Harmonized Tariff System for imports into the U.S.
International Freight Forwarder www.ncbfaa.org	International Freight Forwarder is an agent for moving cargo to an overseas destination. These agents are familiar with the import rules and regulations of foreign countries, the export regulations of the U.S. government, the methods of shipping, and the documents related to foreign trade.

Along with on-campus trainings, the faculty lead customized on-location workshops as well as distance education courses.</p>

Kansas Department of Agriculture — Livestock Export Certification www.agriculture.ks.gov	<p>Interstate shipment of livestock requires official identification and certificate of veterinary inspection or other documentation. Some exemptions may exist. Consult the KDA Division of Animal Health Import and Export Regulations for a complete list of requirements or call 785-564-6601. Before exporting livestock from Kansas, contact the state of destination for their livestock import requirements.</p>
Office of the U.S. Trade Representative www.ustr.gov	<p>The Office of the U.S. Trade Representative is responsible for developing and coordinating U.S. international trade, commodity and direct investment policy and overseeing negotiations with other countries. This is a gateway to information on all Free Trade Agreements and Trade Promotion Agreements the U.S. has with other nations.</p>
Kansas Department of Agriculture — Plant Export Certification www.agriculture.ks.gov	<p>To export live plants outside of Kansas, it will likely be necessary to obtain a Live Plant Certificate of Inspection or other certification from the Kansas Department of Agriculture. Complete a Request for Export Inspection, and a Live Plant Inspection Application. For more information, consult the KDA Export Services and Application Center webpage or call 785-564-6698.</p>
U.S. Dept. of Commerce — International Trade Administration www.trade.gov	<p>The International Trade Administration strengthens the competitiveness of the U.S. industry, promotes trade and investment, and ensures fair trade through the rigorous enforcement of U.S. trade laws and agreements.</p>
U.S. Grains Council www.grains.org	<p>The U.S. Grains Council develops export markets for U.S. barley, corn, grain sorghum and related products, including ethanol and distillers dried grains with solubles. The council tailors its programs to meet individual countries' cultures and needs. Their technical programs teach livestock and poultry producers how to use feed grains effectively and manage their operations efficiently. Their trade servicing efforts educate potential and current customers about the U.S. marketing system, including financing, government programs, prices and feed grains quality. Their trade policy initiatives identify foreign barriers to U.S. feed grains exports.</p>
