Re: In the Matter of the City of Hays' and the City of Russell's Applications for Approval to Change the Place of Use, the Point of Diversion and the Use Made of the Water Under an Existing Water Right, regarding the R9 Water Rights (i.e., regarding the Master Order issued March 28, 2019); Preliminary Municipal Well Legal Descriptions

Dear Messrs. Dougherty and Quinday:

This letter concerns the legal descriptions for the 14 consolidated, preliminary municipal wells described in the change approvals attached and incorporated as Exhibits 1–32 (the "Change Approvals") into the Master Order Contingently Approving Change Applications Regarding R9 Water Rights (the "Master Order"), which Master Order was issued on or about March 28, 2019, to the cities of Hays and Russell (the "Cities"). Thank you and the Cities for bringing this issue to our attention.

As we understand the issue, the Change Approvals were inadvertently issued with minor inconsistencies regarding the legal descriptions for the preliminary municipal wells, wells A–N: For all such wells except well J, the portions of the legal descriptions that describe the feet distances north and west of the southeast corners of sections are minimally inconsistent with the legal descriptions intended by the Cities and with the well-location maps attached to the amended change applications. That is, such descriptions in the Change Approvals state the feet north and west of the section lines of the appropriate sections, rather than distances from the southeast section corner (as is DWR's normal practice). The differences in locations between those approved versus those intended range from 0 to 217 feet. It is further DWR's understanding, however, that all of the well-location maps attached to the amended change applications (which maps show the preliminary well locations and the surrounding permissible well-location areas, in purple and in cross-hatching), show the intended preliminary well locations, and are based off of the intended legal descriptions, for all 14 preliminary municipal wells.

Previously, Mr. Traster had notified me, via a letter dated August 20, 2018 (enclosed for your reference), that the legal descriptions in the Cities' then-pending change applications needed this inconsistency corrected and that the Cities intended to amend their change applications accordingly.

Subsequently, however, the corrected legal descriptions inadvertently were not transferred into the Cities' amended change applications and the Change Approvals were issued with these inconsistencies. The Cities then brought this issue to DWR's attention, as explained in Mr. Buller's letter to DWR dated May 3, 2019 (enclosed for your reference). That letter lists, in its Table 3, the intended legal descriptions for all of the preliminary municipal wells.

With the well-location maps being correct, DWR deems the minimally inconsistent legal descriptions in the Change Approvals to be harmless clerical errors that do not affect the operative provisions and restrictions of the Master Order and its Change Approvals, as further explained below.

Because the Master Order authorizes the preliminary municipal wells to be drilled anywhere within the areal restrictions as shown on the well-location maps attached to the amended change applications, the minimally incorrect legal descriptions in the Change Approvals effectively are moot for all preliminary municipal wells except for wells G and H. Except for wells G and H, the incorrect legal descriptions for the preliminary municipal wells nevertheless place such wells within the approved areas shown on the well-location maps, i.e., in conformity with the areal restrictions approved and ordered in the Master Order. See, e.g., Master Order, Subsections VIII.A. and XVIII.

Regarding wells G and H, although the incorrect legal descriptions in the Change Approvals place such wells slightly outside the correct, approved areas shown on the well-location maps, the incorrect legal descriptions must yield to the approved areas. The Master Order orders that "the areal restrictions (shown in purple and in cross-hatching) around the preliminary municipal well locations as shown on the maps attached to the Change Applications, are reasonable and are approved. The proposed municipal wells A—N are authorized to be drilled within those areas without filing an application to change the point of diversion." Master Order, ¶246. Furthermore, each of the Change Approvals, including those that reference wells G and H, limits the particular approved preliminary municipal well "to be completed within the mapped boundaries as shown on the maps . . . accompanying the Change Application, and pursuant to the Master Order." Thus to the extent that the legal descriptions for wells G and H (and for any other preliminary municipal well, for that matter) might conflict with the corresponding well-location maps, the maps control.

This letter amounts to DWR's notice that it intends to enforce the terms of the Master Order and Change Approvals, as necessary, in conformance with DWR's interpretations herein.

Re: Hays/Russell/R9 Ranch Proposed Municipal Well Locations

Dear David,

This letter describes minor corrections to the distances North and West of the Southeast corners of the Sections on the R9 Ranch that are needed for each of the 14 municipal wells proposed by the Change Applications filed by Hays and Russell. The corrections are to the descriptions of the well locations; the well locations themselves do not change.

As we have discussed, the Transfer Application filed in January of 2016 needs to be amended to conform to the terms of the final Master Order and to address a few additional issues. In addition, some or all of the Change Applications will need to be amended. While we cannot amend the Change Applications or the Transfer Application until the terms of the Master Order are finalized, we have been working on a draft of the Amended Transfer Application.

The following table shows the proposed locations of the 14 municipal wells as set out in the Change Applications and the Change Approvals.

Because some of the well locations may have been adjusted during the process, we asked Burns and McDonnell to confirm the accuracy of the well locations in the table. Daniel Clement compared these locations with the KGS PLSS Sections layer and confirmed that the quarter calls are accurate.

However, the distances North and West of the Southeast Corner of each Section are not accurate. The distances in Table 3 are the distances from the Section lines rather than from the Southeast Section Corners.

The distances are different because, as shown in the attached images, the Sections are not perfectly square and North/South (T25S/T26S) and East/West (R19W/R20W) corrections lines intersect in the middle of the Ranch.

Assuming the accuracy of the KGS PLSS Sections layer, which was also assumed for the previous descriptions, Mr. Clement calculated the distances North and West of the Southeast Section Corners and the UTM NAD83 coordinates for each well. The distances of each proposed well location from the Section Lines, from the Southeast Section corners, and the differences are shown in the attached table.

Since DWR's standard practice is to describe well locations with distances from the Southeast corner of the Section we believe that everyone would be best served to amend the descriptions to conform to that practice.

The Revised Municipal Well Locations table below has the corrected descriptions for the 14 proposed Municipal Wells. These locations will be included in the Amended Transfer Application and in each of the Amended Change Applications when filed.

The draft Master Order does not include the specific well locations. Instead, the following text is included in paragraph 136, "Specific well locations are more particularly described in the Change Applications and the Change Approvals." Similar text is included in paragraph 174. No changes are needed in the text of the Master Order but the table could be added as an appendix to the Master Order if it would serve a useful purpose.

The distances North and West of the Southeast corner of the Section in each of the Change Approvals will need to be amended but the descriptions are otherwise

accurate. For example, the draft Change Approval for File 21,729 D-1 will need to be changed as follows:

[A]nd the location of the point of diversion for the Water Right shall be authorized from one (1) well located as follows:

one (1) well (Well A) located in the Northeast Quarter of the Northeast Quarter of the Southwest Quarter (NE¼NE¼SW¼) of Section 29, more particularly described as being near a point **2,264 2,259** feet North and **2,568 2,705** feet West of the Southeast corner of said section, Township 25 South, Range 19 West, Edwards County, Kansas, in a quantity not to exceed 122.520 million gallons (376 acre-feet) of groundwater per calendar year at a diversion rate not in excess of 945 gallons per minute (2.11 c.f.s.),

to be completed within the mapped boundaries as shown on the maps marked Exhibits M and N accompanying the Change Application, and as provided in the Master Order.

The proposed locations themselves are not moving so the buffers around each proposed well location within which municipal wells may be drilled without having to file an application to change the point of diversion remain accurate. Thus the maps attached to the Change Applications do not need to change.



Brent and Aaron,

As you are aware, the location of the municipal points of diversion are accurately reflected in the overhead maps attached to the individual Second Amended Change Applications and as referred to by the Change Approvals. As you also know, we provided updated legal descriptions that comply with DWR's practice of measuring well locations north and west of the southeast corner of the quarter section via a letter to DWR on August 20, 2018. Unfortunately, those revised descriptions were not transferred into either the Second Amended Change Applications or the Change Approvals. Due to this clerical error, the legal descriptions of the municipal wells in those documents are minimally incorrect.

After conferring with Burns & McDonnell and you throughout this week, we have verified the accuracy of the municipal well locations, which are set forth in the below table.
