If they do not comply I will send a certified letter and explain the issue again. I usually do not have to go past this point as everyone knows how infestations on their ground are not a good practice and will hinder their growing crops.

I also attend CWDAAK Annual Conference in March to get recertifications I need, learn about new chemicals, chem shortages, weed laws and everything else that pertains to Noxious weeds.
